### **ANNUAL MEETING**

### **BUSINESS BOOT CAMP**

The Section completed its fourth nine-month Business Boot Camp program. Cosponsored by ICLE, it offers a series of seminars on fundamental business law issues. It is intended to increase young lawyer participation in the Section and allow law firms to outsource associate training. The program ran from September, 2006 through May, 2007, and was presented in both Grand Rapids and Plymouth. There were 36 registrants in Grand Rapids and 82 registrants in Southeastern Michigan.
