### Section Activities:

In August 2006, the Section filed in the Michigan Supreme Court an amicus brief on behalf of appellees in *Hartman v Eichhorn/Liss v Lewisto*n addressing the issue of whether a licensed residential builder is exempt from the MCPA under the "specifically authorized by law" exemption. Council member Gary Victor wrote the amicus brief.

In November 2006, the Section also filed in the Michigan Court of Appeals an amicus brief in the case of *Davis v Forest River* seeking an affirmance of the trial court rulings. The case involved liability of the manufacturer of an RV under implied warranty and Magnuson-Moss theories, including use of revocation of acceptance as a Mag-Moss remedy. Council member Dani LiBlang wrote the amicus brief for the Section.

In February 2007, the Section assisted in the creation of an ad hoc coalition named the Campaign to Protect Michigan's Consumers. The mission of the Campaign is to seek vigorous consumer protection through legislation and education. To that end, the Section and the Campaign to Protect Michigan's Consumers addressed legislation around the Michigan Consumer Protection Act (MCPA) and predatory mortgage lending. At a House Committee hearing, Council member Fred Miller testified on behalf of the Section and the Campaign. We applauded the House Committee in its attempt to fix the MCPA (HB 4217) and offered suggestions to eliminate the exemption created by the *Smith v Globe Life* case. On behalf of the Section, Council member Michael Nelson also presented testimony before a Senate Committee hearing on the appraisal fraud package bills (Senate Bills 342, 343, 356). The Section did not support those bills as they do not address the problem of predatory lending.

#### Future Goals and Activities:

Continue to seek vigorous consumer protection in Michigan through legislation, education, and litigation by way of amicus briefs.
