#### Legislative Issues:

Continued support for foreclosure legislation with many members testifying at legislative hearings on the proposed legislation, led by Lorray S. C. Brown and Fredrick L. Miller

Supported bills introduced in the legislature which would amend the Michigan Consumer Protection Act to address issues raised by *Smith v Globe Life* and *Liss v Lewiston-Richards, Inc.*, to again make it a viable act in Michigan, to protect consumers.

#### Recommendation for Next Council:

Continue to work to pass legislation on Predatory Lending, Foreclosure and the MCPA.

Develop a program for consumer education on issues of interest, for the public.
