The standing Committee on Justice Initiatives (CJI) was created in 2003 to coordinate the activities of the former Access to Justice Task Force, Access to Justice Campaign, and Open Justice Commission. Its jurisdictional statement provides that it "Shall promote the effective delivery of high quality legal services to all Michigan citizens, and to assure that barriers are reduced so that the justice system is the strongest possible, equal and fair in its application to all." The Committee does its work through its Initiatives: Equal Access, Pro Bono, Legal Aid and Resource Development. Additionally, the Committee commissioned a one-year planning committee whose report was adopted in May. The State Bar President appointed all Committee, Initiatives, and Planning Workgroup members.

- Received information on the State Planning Body;
- Provided input to our committee member who sits on the Commission considering modifications to the ABA Law School Issues;
- Participated in national efforts to promote access to justice and equal access, including (1) sending CJI Co-Chairs and JI Director to attend and present a menu of pro bono activities at the Equal Justice Conference, (2) sending a volunteer to the National Consortium on Racial and Ethnic Fairness in the Court, and (3) sending CJI Co-Chairs and JI Director to national Access to Justice Chairs meeting;
- The Planning & Evaluation Committee's task is to evaluate and prioritize the JI division's work for the coming year review work plans of existing initiatives and evaluate them. The group should obtain some sense of whether projects are meeting expectations or not and keep in mind the reality that we can only do so much and decide if a project is valuable and should continue and if not, that will tell us what resources we have to lend to other possible work. 2005-06 Meeting Schedule (date and location):

A joint meeting of the CJI and all of its initiatives was held at the State Bar Building in Lansing, Michigan on October 19, 2005. The Resource Development Initiative is organized into two distinct activities (ATJ Campaign and ABA Day), and the Campaign is organized into a Statewide Campaign with ten regions, two corporate committees, and a major gifts committee. An estimate of total meetings for all campaign committees is roughly twenty five to thirty. The ABA activities were achieved with three to five meetings.

- Year-end activities for the 2005 ATJ Campaign were successful with the 2005 Access to Justice Campaign receiving approximately one million dollars in new cash and pledges. Last year's contributions from 1,753 donors was about \$225,000 more than the average collected in previous years;
- The Southeast Michigan Access to Justice Corporate Committee, led by E. Christopher Johnson of General Motors, hosted over thirty large law firm and corporate leaders for a luncheon at the Detroit offices of Miller Canfield on November 14, 2005;
- More than \$22,000 in gifts was raised in Grand Rapids on February 16, at a State Bar of Michigan corporate reception to benefit the Access to Justice (ATJ) Fund. Contributions given at the reception will directly support ATJ-eligible programs including the west Michigan-based Legal Assistance Center, Michigan Migrant Legal Assistance Project, Inc., and Legal Aid of Western Michigan;
- In an effort to capitalize on the \$115,000.00 Access to Justice contributions realized from two court awards in 2005, ATJ staff completed a twenty-three page Cy Pres "how to" manual in January 2006. The manual is a resource for judges, lawyers, professional associations, legal aid programs, staff, and others interested in directing unclaimed class action residual and settlement funds to Michigan's non-profit legal aid providers;
- A structured stewardship program involving additional recognition for the ATJ Campaign donor society members was implemented;
- An ATJ Campaign Retreat was held to broaden the annual Access To Justice Campaign through fundraising coordination with the ATJ eligible programs. This Retreat will be offered again on September 28 & 29 in 2006 in the Lansing area. Information provided will cover working through the ATJ Campaign and fundraising methods including primary fundraising techniques, strategies for soliciting funds from individuals and from organizations, and creating annual development plans for 2007-08. The Justice Initiatives Division hosted a two and one-half day retreat in East Lansing on September 12-14, 2005. Forty attendees

representing 26 programs received hands-on information on fundraising, coordinated grant seeking, and sustainability. Justice Initiatives coordinated the videotaping of twenty customized ATJ public service announcements for many retreat attendees to use to market their programs through local media outlets and on their program websites.

CRIMINAL ISSUES WORKGROUP

The Criminal Issues Workgroup was asked to consider whether criminal issues can or should be addressed by the CJI, a committee of a bar with compelled dues, and if so, what aspects of that work should be targeted for the next 3 to 5 years and what structure should be used to address its work.

Two topics emerged under which criminal issues work should be organized - representational issues (how to gain access to qualified legal assistance and the forums where representation is necessary) and collateral consequences (civil and social obstacles stemming from certain convictions that pose significant barriers to post conviction success.) The workgroup discussed addressing these problems with a holistic approach as a serious concern is fragmentation issues that lead to lost opportunities.

Three proposed projects were adopted for implementation:

- 1. Conference on Civil Collateral Consequences of Criminal Convictions (developing and disseminating checklists, tools, training module and other materials to inform practitioners and other stakeholders) This was seen as a longer-term project. Writing, planning materials and presenters could go in tandem. This should be a secondary focus for CIW.
- 2. Assist National Legal Aid and Defender Association (NLADA) in Data Analysis (and best practices model for determining methodology in appointed criminal cases for appointment of counsel, payment of counsel, and expert witness support) CIW should be a collaborator in the data collection with NLADA. Legislative resolution is clearly intended to build understanding and finding of criminal indigents. Some of the proposed data collection has the advantage of getting into people's hands right away.
- 3. Create Handbooks (for courts and/or assigned counsel) CIW must be realistic regarding what can and can not actually be done. The handbook has the advantage of getting into people's hands right away. The Handbook proposal should be CIW's primary focus.
