In support of the Committee, the State Bar of Michigan provides a meeting room at the Michael Franck Building as well as lunch for the Committee. A staff liaison is assigned to coordinate the interview schedule with the Governor's Office, submit a report to the Governor indicating the Committee's ratings for each candidate and handle the administrative work.

## **Committee Activities:**

As requested by the Governor, the Judicial Qualifications Committee interviews, evaluates and rates candidates for appointment to judicial vacancies. Interview preparation, Committee discussion and final ratings are confidential, and reported directly to the Governor.

Prior to the interview, the application is assigned to one Committee member who contacts lawyers in the community to obtain background information regarding the candidate. The Reporter, a representative of the Attorney Grievance Commission, prepares and presents background information obtained from local judges and grievances filed against the candidate, to the Committee. All interview sources are kept confidential.

A representative from the Governor's Office and the State Bar Staff Liaison are also present during the interview. The Committee meets on the second Tuesday of the month as needed.
