Committee Activities:

Many of the members of the newly formed Technology committee met face-to-face on March 20th at the State Bar Building in Lansing for a lunch meeting. The committee has had a total of six meetings to determine direction and goals for the year. The committee meeting in January was particularly useful with participation by the State Bar President Ron Keefe and State Bar Executive Director Janet Welch. Both executives provided a historical perspective on how the committee was formed and gave the committee members encouragement to venture into unchartered territory.

The committee is researching how it can attain the goal of the committee's jurisdictional statement to "Assist the State Bar in evaluating, promoting, and implementing new technologies in law practices, courts, and bar associations, to provide greater services to lawyers and the public." In this regard, members of the committee have volunteered for the three distinct areas of 1) law practices; 2) courts and 3) bar associations. The committee plans to utilize this research to identify the technology challenges in each of those three areas. Jeff Kirkey (law practices), Mark Dobias (courts) and Vince Polley (bar associations) have volunteered for each of these areas. Once the top technology challenges are identified, the committee will then make suggestions and proposals to the State Bar on how the committee can best assist the State Bar in evaluating, promoting, and implementing new technologies. The committee also plans to utilize the fruits of the committee's research by working with Anne Vrooman to provide technology related questions for the next bar membership survey.

The committee has been asked to comment on the proposed MRE 902A regarding Electronic Evidence. The committee discussed the proposed rule during a conference call on April 24th and will be providing comments on the proposed rule soon.

William Kramer of the State Bar deserves kudos for his involvement with the committee. William has been instrumental in coordinating the efforts of the committee and has taken an active role in helping research the technology needs of bar associations.

Steve Gray deserves thanks for suggesting and implementing a listserve so that the committee members can more effectively communicate with each other.
