#### **Committee Activities:**

- 1. Continuous exchange of information between the Eastern and Western Districts of Michigan regarding operational and administrative functions and procedures in each District that might be of interest to or benefit the other District.
- 2. Continuous exchange of information between the Eastern and Western Districts of Michigan regarding Bench-Bar Conferences in each District and opportunities for cooperation and cross-districting between the two districts with regard to future Bench-Bar Conferences.

- 3. Systematically reviewed proposed federal rule amendments and submitted comments on the proposed amendments regarding FRE 804(b)(3), Fed.R.Civ.P 26(a) and (b) and to Fed.R.Civ.P.56 to the Federal Rules Advisory Committee.
- 4. John Allen addressed the committee regarding a report that he helped author as a member of the ABA Special Task Force on Attorney-Client Privileges and that was presented at the ABA Mid Year Meeting in Boston.
- 5. Formation of a task force to investigate and explore options for the representation of *pro se* non-prisoner civil litigants who survive summary judgment.
- 6. The annual bench-bar dinner with judges and magistrates judges of the Western District (alternates yearly with the Eastern District) is scheduled for May 20, 2009, at Doubletree Hotel, in Detroit. It provides an opportunity for the judges to meet the committee members and discuss common issues.

# Resources Provided by the State Bar of Michigan in Support of Committee Work:

The State Bar provided the Roberts P. Hudson room at the State Bar of Michigan for meetings, equipped with telephone conferencing equipment so members unable to attend in person could attend by teleconference. Dinner was provided at each meeting and Bar Staff Liaisons Clifford T. Flood and Anne Smith attended meetings, assisted in preparing and circulating meeting agendas and minutes for each meeting, took minutes of each meeting, and provided other administrative support, as needed. In addition, the State Bar of Michigan provided the resources called for in Article VI, Section 7 of the State Bar of Michigan Bylaws. The State Bar of Michigan was responsible for the expenses for the Annual Bench Bar dinner.

# Future Goals and Activities:

- 1. The Committee wishes to continue with the process for systematically reviewing and commenting on amendments to the Federal Rules and submitting draft amendments, when appropriate.
- 2. The Committee intends to focus on a statewide Bench/Bar Conference in 2010 by coordinating the activities of the FBA chapters in an effort to assure that the conference remains meaningful and attractive to the judges and practitioners. The Committee intends to form a task force or sub-committee to facilitate this goal.
- 1. The Committee wishes to appoint a committee co-chair at the first meeting each year following the State Bar's Annual Meeting in order to promote consistency and continuity in the Committee from year to year.
- 2. The Committee's future plans include inviting the Federal Bar Presidents of the Western and Eastern Districts to future meetings and including both Western and Eastern District judges at the 2010 Bench Bar Conference.
