It is with great pleasure that I nominate Clark Andrews for consideration for the State Bar of Michigan Unsung Hero Award. Clark has worked for O'Reilly Rancilio P.C. for 45 years, having started at the firm shortly after his graduation from the University of Michigan Law School in 1974. Clark is a member of the firm's municipal, estate planning, and business and real estate practice groups. He has worked as an assistant city attorney for the cities of Sterling Heights, Fraser, and Utica, and as an assistant township attorney for the townships of Shelby and Macomb.

Clark has undoubtedly made his mark in the legal world, and it is through his numerous community activities and his big heart that we ask for your consideration to select him as an Unsung Hero. He served as an appointed volunteer member of the Macomb County Legal Assistance Program for Senior Citizens Board from 1991 until 2013, when the program was discontinued for funding reasons.

The Board that Clark served on oversaw and counseled two staff attorneys of the pro bono program which provided legal assistance to seniors. The Board met quarterly (or more often when needed) to discuss cases, caseloads, client confidentiality, and other ethical issues which arose during the time that the program operated. In addition, he provided some pro bono services, and was awarded the 2013 Pro Bono Service Award Senior Services for those contributions.

Clark was also a volunteer member of the Professional Education Committee of the Michigan Municipal Attorneys Association for several years. The MMA often collaborated with the Public Corporation Section of the State Bar of Michigan in producing and delivering high quality continuing education seminars on topics of current interest to municipal attorneys and their municipal clients. In the summer of 2010, Clark was a speaker at the Michigan Public Corporation Section summer seminar regarding then recent changes to the Michigan Smoking laws and how those affected municipalities and businesses.

Clark has also been an active supporter of the Salvation Army William Booth Legal Aid Clinic which provides legal services to impoverished individuals in the tri-county area. Clark also supports the Macomb County Bar Foundation and the Kim Cahill Scholarship fund.

Clark is a very active participant in several business, community, and civic organizations. He has been an active member of the Rotary Club of Sterling Heights for 45 years. The service club whose motto is "Service Above Self" has done many good deeds to improve people's lives, including purchasing, distributing, and fitting free bike helmets to youth, offering college scholarships to needy students, holding annual Valentine's Day parties and December holiday parties for special needs students in Macomb County, funding youth leadership retreats, and delivering fully-prepared meals to numerous families on Thanksgiving Day. Clark also participated actively in the Sterling Heights Cultural Exchange which is held annually to promote understanding among people of different cultures.

Clark has also actively participated in activities with the Utica Community Schools Foundation for Educational Excellence, including volunteering every year as a business leader at the annual Career Focus Luncheon of 2000 sixth graders for more than 20 years.

Through the Blessings in a Backpack and Macomb Foundation programs, Clark has collected and donated many backpacks and school supplies to needy elementary school students. He has recently participated in the Sterling Heights Drug Free Coalition, and the COMEBACK-Quick Response Team programs which are helping to raise drug awareness and provide on-the-ground treatment to individuals who have overdosed.

Clark has volunteered as a Director and served as President of the Sterling Heights Regional Chamber of Commerce & Industry, and helped form the Sterling Heights Regional Chamber of Commerce Foundation. He was awarded the Sterling Heights High School S.O.S. Club Award for Service to Youth, and the Lil Adams Award for Contributions to the Sterling Heights Regional Chamber of Commerce and Industry.

At O'Reilly Rancilio P.C., Clark serves as a mentor to new attorneys teaching them about his areas of expertise, how to ethically practice law, and most importantly how to enjoy the profession. He often accompanies young lawyers to municipal meetings and other community events providing guidance and advice.
