Edwards; March 2004 Alternative Careers for JDs by Lance M. Werner; May 2004 Litigation Searching by Kimberly Koscielniak; June 2004 Internet Research in Negligence Law by Barbara H. Goldman; and July 2004 Native American Legal Resources on the Web by Lance M. Werner and Jane M. Edwards.
- Committee members are finishing work on our Michigan Online Legal Self-Help Center web page project, designed to help Michigan citizens find legal resources and work better with their attorneys.
- The Committee also reviewed pending legislation and voted to oppose HB 5390, which would limit the deposit in the State Library of public documents that are also available on the Internet. The Committee was concerned that archiving of electronic documents has not developed to the point that we can be confident documents will be preserved and retrieved. The SBM Board of Commissioners also subsequently voted to oppose the bill in principle.

Resources Provided by the State Bar of Michigan in Support of Committee Work:

The State Bar provided meeting space and lunch for our February 21, 2004 committee meeting and reimbursed committee members for lunch expense for our other meetings. Sharon Barnes, Susan McMann, Janet Welch, Elizabeth Lyon, and Amy Ellsworth have been extremely helpful in arranging meeting space and refreshments; communicating the Committee's position on legislation and other reports; keeping us informed of public policy developments; and assisting with editing and publication of Committee member articles in the Bar Journal.

Future Goals and Activities:

At a minimum, Committee members plan to continue providing quality articles for publication in each theme issue of the Bar Journal, relating to electronic legal research for the featured theme. We also plan to promote our Michigan Online Legal Self-Help Center web page; and monitor legislation and technology relating to the availability of legal resources to members of the Bar and the public.
