Committee Activities:

Prior to the January meeting the co-chairs and staff developed uniform concise nomination forms for the Hudson, Kelley, and Champion awards. In January, the committee reviewed and approved the

forms. Committee members reviewed the Awards brochure, mission, policies, procedures and awards criteria for the Hudson, Kelley. Champion and Liberty Bell awards. The group also set the deadline for nominations and arranged for announcements in the Bar Journal and SBM electronic media (e-journal, SBM newsletter, e-mail), direct mail to local and specialty bars, and press releases.

In February and March, various committee members solicited nominations from local and specialty bars and past SBM presidents. In April, the committee preliminarily reviewed a package from staff with all nomination materials for 31 nominees¹, noted which nominees have won other SBM awards, and reviewed the voting procedure for the May meeting.

At the May meeting, the committee conducted a detailed review of nominees and voted to make recommendations to the Board of Directors for the Hudson, Kelley, Champion and Liberty Bell awards. The committee made no recommendations this year to the Board regarding criteria, new awards or the elimination of awards.
