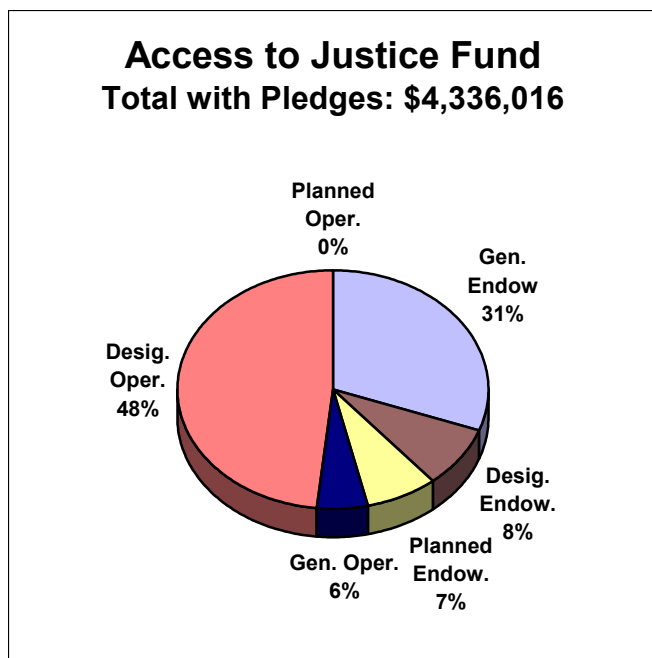
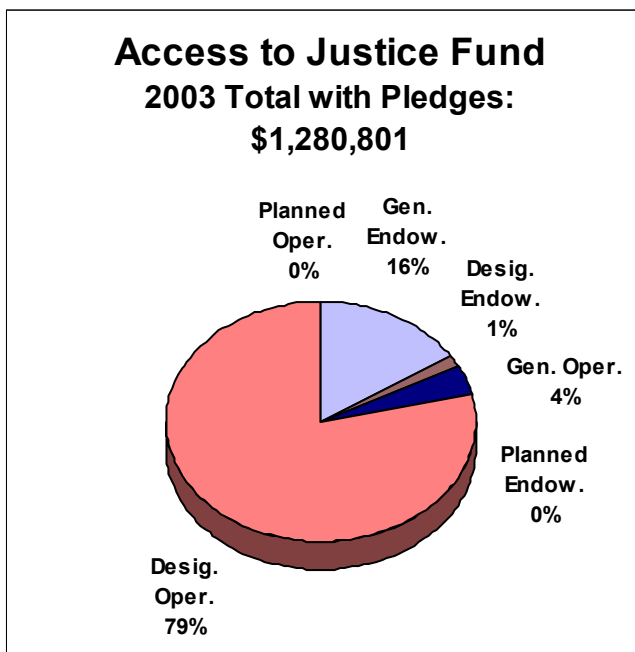

Introduction

The State Bar of Michigan, in partnership with the Michigan State Bar Foundation and legal services providers throughout the state, conducted the sixth year of an Access to Justice fundraising campaign during 2003. Bar support for a private fundraising strategy was implemented through a state planning process that occurred in 1995 and was reaffirmed in 2000. Through that process, the State Bar agreed to provide leadership and staff support for such a campaign, and the first donations to the Access to Justice Fund were received in late 1998.

Campaign Achievements

Over \$1.2 million in new cash and pledges was raised from 1,821 donors for the Access to Justice Fund in 2003, making it the most successful fundraising year ever. This includes the largest single gift to the Campaign, a donation of over \$600,000 from the Kellogg Foundation designated for a legal aid program to provide education and advocacy in the Battle Creek area.



To date, the Fund has raised over \$4.3 million in cash, pledges and planned gifts. To help provide long-term stable funding for legal aid services into the future, donors are placing almost 50% (over \$2 million) of their total gifts pledged into permanent endowment funds.

Even so, a higher percentage went to designated operation funds during calendar year 2003. This was encouraged by the Campaign to assist legal aid programs with current operating money in light of a reduction in federal funding in Michigan due to the shifts in poverty populations. Of the 2003 Campaign total, nearly \$600,000 was distributed directly to programs designated by donors for operations support. A designated distributions report is attached.

Cost Per Dollar Raised

During calendar year 2003, total State Bar direct costs for the Campaign were \$139,742. The Bar was reimbursed for \$53,675 of those costs through designated donations and grants, leaving net unreimbursed direct costs of \$86,067. Under Campaign policy, the net unreimbursed costs are added to the \$1,280,801 funds raised, for total revenue of \$1,366,868; total direct costs are then divided by total revenue for a cost per dollar raised of \$0.102. That figure is considerably lower than the guidelines established for the Campaign¹ and well below industry limits. Donors should know that in 2003, no portion of their ATJ contribution was used toward fundraising expenses.

Leadership

Active participation of State Bar officers in Campaign leadership positions was key to success in 2003. Those positions included the Campaign Cabinet Chair, filled in the first part of the year by President Reginald Turner, and the Statewide Campaign Committee Co-Chairs, President-Elect Scott Brinkmeyer and Vice President Nancy Diehl. With the new State Bar leadership year, Diehl assumed responsibility for the ATJ Campaign and functioned as its Chair. Regional leaders throughout the state joined her, including many members of the Board of Commissioners.

The Corporate Committee's membership was revised to reflect the end of a three-year commitment made by a founding member, and the move out of state by another member. New leadership was recruited to include the General Counsel of Ford Motor Company and the General Counsel of Dow Chemical Company.

The work of the Foundation Campaign Committee continued under the guidance of its chair, Bill Brodhead. A Major Gifts Committee was added to the structure and the Special Needs position was eliminated. The Internal Cabinet, which serves as a policy-making body for the Campaign, did not have a need to meet during 2003. A map of Michigan showing the ten Campaign regions and 2003 leaders is attached to this report.

Goal Setting and Strategies

A preliminary goal to raise one million dollars was set by staff based on funds raised regionally during previous years of the Campaign, the total number of previous donors, and the number of attorneys located in the individual regions. Those goals were provided to the Statewide Campaign Committee early in the year. Each regional leader was given a general set of strategies for conducting a campaign in any region, and a suggested plan tailored for use in his or her region. A Regional Campaign Report outlining regional campaign results is attached.

Successes and Strengths

- **One Hundred Percent Leadership Participation:** The Campaign achieved one hundred percent support from key leadership groups, including the State Bar of Michigan Board of Commissioners, Access to Justice Task Force, Legal Services Association of Michigan,

¹ The guidelines provide that the costs per dollar raised should be less than 37% until 2005 (the "start up" phase), less than 25% for all future years, with a goal after 2004 of achieving an expense/revenue ratio for a mature campaign in the 17-19% range.

Michigan State Bar Foundation Board of Trustees, Michigan State Bar Foundation Staff, State Bar of Michigan Lawyers and Judges Assistance Program and the Access to Justice Statewide Campaign Committee.

- **Kellogg Foundation Grant:** The W. K. Kellogg Foundation awarded a \$653,218 grant through the ATJ Fund to Legal Services of South Central Michigan. The grant supports LSSCM's education and advocacy program in the areas of rental housing and public benefits for low-income people in the Battle Creek area.
- **Past Presidents' Dinner:** Revenues from a benefit dinner hosted by State Bar immediate past president Reginald M. Turner totaled nearly \$100,000, resulting in almost \$75,000 (net of expenses) for the Access to Justice Fund. Michigan Governor Jennifer Granholm joined over 160 guests at the Charles J. Wright Museum of African American History to honor Turner for his leadership and commitment to the access to justice effort.
- **Michigan Trial Lawyers Association:** The MTLA Campaign yielded \$62,158 from a total of fifty-seven donors. MTLA members have contributed \$324,125 toward their cumulative goal of raising \$500,000 for the ATJ Campaign. This amount represents all contributions from known MTLA members since the beginning of the Campaign.
- **Law Firm Participation:** The large law firm work of Bob Gilbert, Miller Canfield lawyer and co-chair of the ATJ Corporate Committee, accounted for a significant amount of lawyer giving in 2003, with \$315,090 of the \$1,280,301 raised attributed to large law firm gifts.
- **DaimlerChrysler Corporation Fund:** The DaimlerChrysler Corporation Fund contributed \$25,000 to the ATJ Endowment Fund in support of civil legal aid programs for the poor in Michigan.
- **\$1000+ Donors:** A total of 1,821 donors participated in the 2003 Campaign. Since the Campaign's inception, nearly 700 donors have made cumulative gifts of \$1,000 and above.
- **Race for Justice:** The 7th Annual Race for Justice, sponsored by the Young Lawyers Section of the State Bar, included nineteen runners, sixteen supporters and eight corporate sponsors. The event raised \$5,000 for the ATJ Fund and was held on September 13 in conjunction with Bar's Annual Meeting.
- **Skate for Justice:** The 1st Annual Skate for Justice was held in Detroit involving law student hockey clubs from the University of Michigan, University of Detroit-Mercy, Wayne State University, Ave Maria law schools and Michigan State University - DCL College of Law. An independent initiative of law students, the event raised \$3,698 for the ATJ Operations Fund.

- **Annual Dues Statement Appeal:** For the fifth consecutive year, the ATJ Fund appeared on the State Bar’s Annual Dues statement. This appeal raised \$28,196.

A postcard appeal for the dues statement checkoff was sent to State Bar members within Region 1 (Upper Peninsula) and Region 2 (Upper Lower Peninsula) four weeks prior to the dues notice. Bar staff drafted a news article encouraging members to use the dues statement to support ATJ, and through the Statewide Campaign Committee, the article was published in several local bar publications.

- **Year-End Activity:** ATJ staff prepared nearly 2,000 year-end letter appeals between November 15 and December 22. Those letters were written to reflect 17 different interests including previous donors in every region who had not yet contributed during 2003, and a direct solicitation to every Bar member in Genesee County. During the week of December 15, State Bar President, Scott Brinkmeyer, sent a year-end email message to all State Bar of Michigan members requesting support for the ATJ Fund. His message suggested donors use the ATJ Fund to support either the statewide endowment or specific local legal aid programs of the donor’s choosing.
- **Program Appeals:** Some programs providing legal services, and their supporters, appealed to their constituents for contributions made through the ATJ Fund. Friends of Legal Aid (for Legal Services of South Central Michigan), Western Michigan Legal Services, Detroit Metropolitan Bar Association, Michigan Migrant Legal Assistance Program, Student Advocacy Center and the Ingham County Bar Association initiated these appeals.
- **Foundation Fundraising Seminar:** On October 30 twenty-two legal assistance agency representatives participated in the Building Program Capacity for Foundation Fundraising and Statewide Coordination seminar at the State Bar of Michigan. This seminar provided attendees with information on the tools necessary for the development of successful foundation proposals in support of access to justice issues, including making the case, researching foundations, and creating a solid ongoing fundraising plan. This seminar was presented by the ATJ Campaign Foundation Committee and funded in part by a grant from the Michigan State Bar Foundation. Participants also paid a registration fee so the event was revenue neutral.
- **Use The Fund Project:** ATJ and Michigan State Bar Foundation staff coordinated efforts to develop a formal informational packet outlining the benefits of partnering with the Access to Justice Campaign and using the Access to Justice Fund to receive charitable contributions

in support of legal assistance programs. The packet was sent to Michigan's legal aid program executive directors, presidents, and known board members. The packet included a sample "Use the Fund" policy, "Benefits of Using the Fund" brochure, sample appeal letter, pledge envelopes and forms, ATJ Case for Support, designated donations eligibility criteria, list of ATJ Fund grants to date, donor recognition booklet, and Fall 2003 donor newsletter.

- **1st Time Donor Year-End Stewardship Letter:** A first-time donor letter, signed by Scott Brinkmeyer, was sent to 235 donors who made a first-time gift to the ATJ Fund during the 2002-03 Campaign. This letter articulated the importance of the donor's support to the ATJ Fund, acknowledged their first-time gift, and encouraged future gifts to ATJ.
- **Golden Celebration Campaign:** A solicitation letter signed by Scott Brinkmeyer was sent to 173 attorneys celebrating their 50-year anniversary in the practice of law. This appeal encouraged individuals to demonstrate their commitment to access to justice for all with a gift to the Access to Justice Golden Celebration Campaign. Donors were encouraged to consider a gift of \$100 for every year they had practiced law for a total gift of \$5,000, which could be pledged over five years. Four donors, two of whom had no past giving record, contributed a total of \$500 for this particular appeal, making the average gift \$125.
- **Statewide Campaign Committee Communication:** The Statewide Campaign Committee held five teleconference meetings between July 14 and November 12.
- **ATJ Campaign Updates:** A total of eight bi-weekly Campaign updates were published and distributed via email between August 22 and December 12. Recipients included the 2003 Statewide Campaign Committee, legal assistance program directors, Board of Commissioners, and Michigan State Bar Foundation staff. The Updates were also included on the ATJ website.
- **ATJ Donor Newsletter:** Two ATJ Donor Newsletters were published and distributed during the spring and fall of 2003. Recipients included ATJ donors as well as State Bar and Campaign leadership. Additional individuals received copies when appropriate.
- **On-line/Website Gifts:** All electronic ads and messages were linked to the ATJ website location where on-line pledges could be made.
- **Marketing Coordination:** Greater emphasis to include the ATJ Campaign in State Bar communications and events occurred through ongoing communication and planning.
- **Staff Developments:** Lesa Smith was hired by the State Bar in June to fill the position of Development Coordinator, and she joined the Mid-Michigan Planned Giving Council and the National Committee on Planned Giving. Jennifer Williams attended the Association of Fundraising Professional International Conference in March. Candace Crowley achieved Certified Fund Raising Executive status.
- **New Eligible Recipient Programs:** The following programs were added to the ATJ eligible program recipient list: Counsel and Advocacy Law Line, Diocese of Kalamazoo

Immigration Assistance Program, Maurice and Jane Sugar Law Center for Economic and Social Justice, and the University of Detroit Mercy Law School Program.

- **Grant Awards:** The Michigan State Bar Foundation awarded the third round of ATJ grants, providing \$35,000 of support to four non-profit program providers. A description of those grants is attached to this report.

Other Accomplishments and Administrative Achievements

- **ATJ Case for Support/2002 Donor Acknowledgement Booklet/Media Releases:**
 - The Case for Support was updated to reflect current leadership.
 - The 2002 Donor Acknowledgement booklet was introduced at the Grand Reception of the State Bar's 68th Annual Meeting in Lansing.
 - Seven media releases regarding the 2003 Campaign were issued and each release appeared in at least one publication.
- **Michigan Bar Foundation Support:** The State Bar's contract with the Bar Foundation resulted in a grant from the Foundation into the ATJ Fund to apply toward the Bar's operating costs of the Campaign.
- **Fundraising License Renewal/Staff Registration:** The Bar renewed its fundraising license with the Michigan Attorney General's Office, and four State Bar staff members were registered as professional fundraisers/solicitors.

2003 Special Recognition

E. Christopher Johnson, one of the organizers of the 2002 Minority Outside Counsel Networking Conference that produced a \$128,000 ATJ donation, was recognized for his work with the presentation of the American Bar Association's Spirit of Excellence Award. Bob Gilbert, a Miller Canfield lawyer and one of the founding members of the Campaign's Corporate Committee, was presented with the State Bar's Champion of Justice Award.

Challenges:

While the Campaign experienced its most successful year ever, there remains much to be done.

- Regional campaigns require significant Bar staff support and yield very mixed results. Notably, the Campaign has been unable to find leadership or convey the ATJ message to areas outside of main regional cities and their surrounding areas.
- Some of the state's legal assistance programs continue to solicit and accept support directly from donors without coordination with the ATJ Fund.

- Support through the Member Dues Statement appeal decreased, perhaps in part because of the increase in dues in 2003.
- Two of our large law firm donors did not participate in the 2003 ATJ Campaign. Efforts to increase law firm giving in the Lansing, Oakland and Wayne County regions did not meet with the desired success.
- There has been a decrease in the number of new major gifts (over \$10,000) from individuals.
- New corporate support was minimal.
- The ATJ message has not yet been directed toward the general public.
- The Campaign functioned for half of the year without full staff.
- The total number of press releases and the level of year-end communications decreased.
- The economic downturn continues to impact development efforts. Continued lingering effects of economic declines contributed to reduced giving levels from individuals during 2003.
- The total number of donors and the amount of giving from individuals declined in 2003. Although the State Bar's membership is approximately 37,788, less than 10% of these members are financially supporting the ATJ Fund.
- Planned giving research diminished in 2003, and a coordinated effort to implement a planned giving program is still pending.

2003 Campaign Activity Conclusion

Given the success of the Campaign in 2003, it is clear that the Bar's long term investment in a private fundraising campaign for civil legal aid is reaping its promised return. Despite the challenges noted above, the effort should continue to grow with strong volunteer leadership, adequate financial support, and a professional membership possessing strong ethical and professional standards.

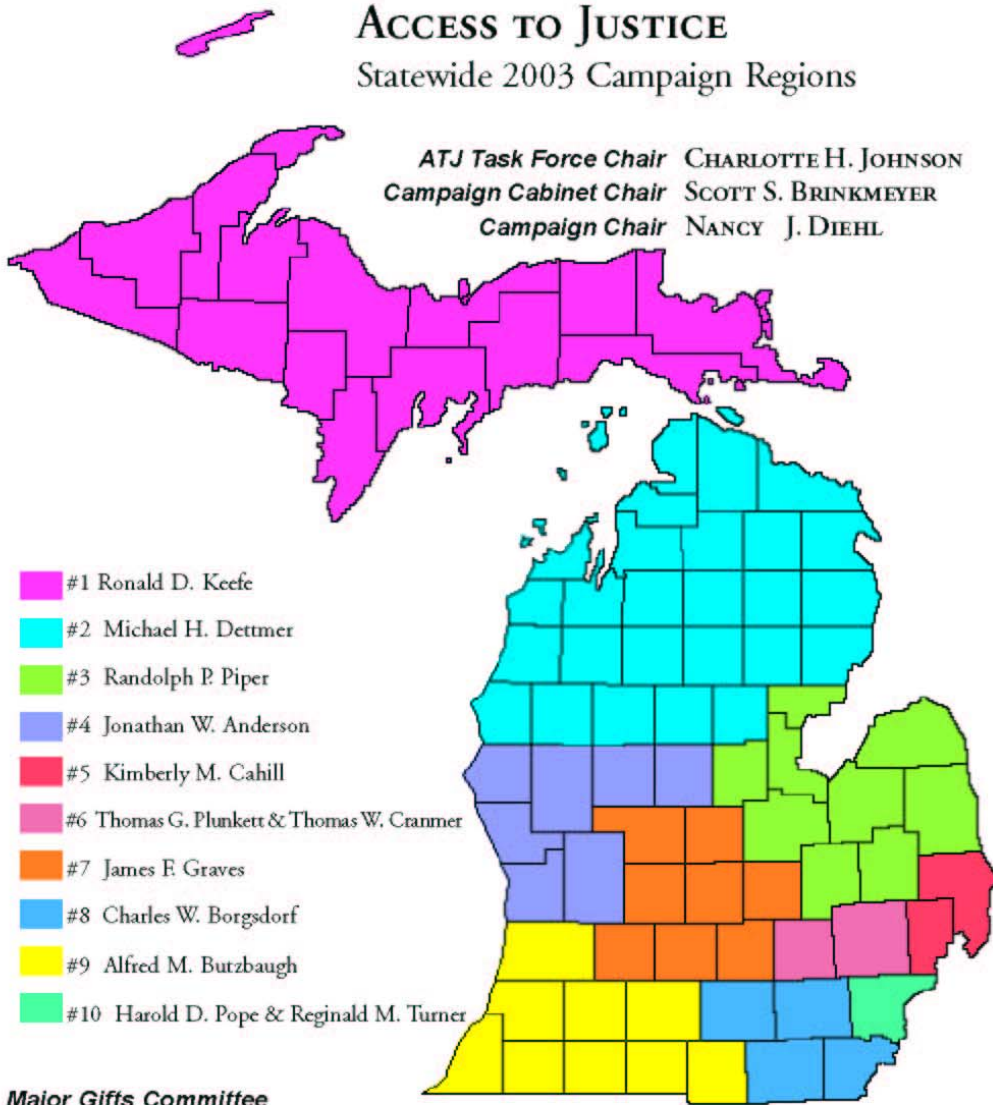

Third Round of ATJ Fund Grants Awarded to Four Nonprofit Agencies

On September 11, 2003, the Michigan State Bar Foundation awarded the third round of grants from the Access to Justice Fund. The State Bar of Michigan and the Foundation thank those lawyers, judges and others whose generous contributions to the Access to Justice Campaign made these grants possible.

Since 2000, a total of \$130,000 in ATJ Fund grants supported 13 innovative projects to help serve low-income families who have no where else to turn with problems such as protection from family violence, recourse from unscrupulous contractors, access to medical care, support for children and other critical civil legal needs. This year, a total of \$35,000 will support the following four projects to help address unmet civil legal needs in our State.

Michigan Indian Legal Services will receive \$6,000 to produce and distribute an Indian Child Welfare Act (ICWA) manual to assist legal aid programs, courts, libraries and others and to distribute an ICWA brochure for parents. These resource will help assure that the law is accessible and will help enhance understanding about issues in cases involving Indian children.

Legal Services of Northern Michigan will receive \$3,000 to purchase a telephone upgrade to give greater access to clients throughout its geographically large 36 county service area through a voice mail module that meets state technology guidelines and allows more seamless integration with other providers for cooperative services and referrals.

Women's Survival Center (WSC) will receive \$20,000 to implement its pro se and family law project which will operate in cooperation with other Oakland County providers and courts and for expenses toward implementing PIKA case management systems for which WSC will serve as a pilot site for using/replicating this software in other domestic violence agencies.

Lakeshore Legal Aid (LLA) and its Counsel and Advocacy Law Line (CALL) will receive \$6,000 for a web access and resource project to expedite services for clients with multiple legal and social needs. CALL will compile community and legal materials for clients and advocates and publish outreach information in an expanded service area, working with the Legal Services Computer Committee to maximize web design and usage for these resources.

The State Bar of Michigan's Access to Justice Campaign raises endowment and current operating funds to improve access to justice for low-income people with civil legal needs in Michigan. The Michigan State Bar Foundation receives and manages the funds and their distribution. Donations from lawyers and judges to the ATJ Fund are one method of satisfying the State Bar's voluntary pro bono standard. 2003 Legal Services Designated Operations Distributions

The following programs received support from the ATJ Fund through donor-designated operations contributions received during 2003:
