This report is being submitted on behalf of the Young Lawyers Section, as required by State Bar of Michigan Bylaw Article VIII, Section 1.

Young Lawyers Section had a very active and successful year. The YLS sponsored the following programs:

- 1. <u>Holiday Dinner for the Homeless</u>. On December 6th and December 13th, the YLS sponsored holiday dinners for the homeless at the Grace Center in Pontiac and the Door Steps Center in Highland Park. Angelique Strong Marks was the chair of this program.
- 2. <u>Race for Justice</u>. On September 12th, the YLS sponsored its annual Race for Justice. Over \$5,000 was raised for the Access to Justice Foundation. J.J. Conway and Andy Portinga were the chairs of this program.
- 3. <u>Supreme Court Swearing-In Trip.</u> On January 20, 2004, nine people traveled to Washington, D.C. to be sworn in at the United States Supreme Court. Wil Steiner was the chair of this program.
- 4. <u>Pro Bono Day</u>. On April 8th, the YLS sponsored Pro Bono Day at the Detroit Legal Assistance Center. Faizah Shabazz was the chair of this program.
- 5. <u>Imprint</u>. The YLS sponsored its annual Imprint Program at Southfield High School. In this program, attorneys corresponded with students regarding a book. This year's book was <u>The Bluest Eye</u>, by Tony Morrison. Jenice Mitchell, Kathy Day, and Michelle Johnson-Tidjani were the chairs of this program.
- 6. <u>Environmental Issues in Business Transactions</u>. On November 13th, the YLS sponsored a round-table discussion on Environmental Issues in Business Transactions. Lavonda Jackson was the chair of this program.
- 7. <u>Senior Lawyers/Young Lawyer Mentoring Program.</u> On February 25, 2004, the YLS hosted a reception to commence the beginning of a Senior Lawyer/Young Lawyer Mentoring Program. This program pairs older lawyers with younger lawyers to encourage
