WE THE JURY

The Young Lawyers Section won a first place ABA Award of Achievement in the Service to the Public category for our We the Jury program in 2005. Based on its success, the program has been continued every year since. The program is designed to introduce the legal system to children and give them an opportunity to participate in a jury selection and trial process. In May 2007, approximately 65 students from Flint Southwestern Academy participated in the "We the Jury" program. The students were brought to the courts and provided educational tours. The students were instructed to pay attention to all of the various careers that they observed while on their tours, such as clerks, deputies, secretaries, attorneys, and judges. Arrangements were made to have the students tour the 67thDistrict Court and holding cell area, as well as the 7th Circuit Court historic courtroom and the modem courtroom. While at the Circuit Court, the students reported to the jury board for the actual jury orientation. Attorneys from the Genesee County Prosecutor's office and defense attorneys participated and tried a fictitious criminal case.

MANAGING LAW SCHOOL DEBT

On Thursday, June 27, 2007, the Young Lawyers Section hosted a program about managing law school debt. The panel included Gail Perry-Mason, an award winning financial planner and author, State Representative Bert Johnson, and representatives from the University of Michigan Law School Office of Financial Aid.
