### **State Bar of Michigan Annual Meeting September 17-19, 2008 Hyatt Regency, Dearborn**

The Criminal Law Section will hold a short business meeting beginning at 9 a.m. on Friday, September 19. During the meeting, elections will be held to fill five positions on the Council. Incoming Chair, Matthew P. Smith, will also be inducted. Our annual program will begin shortly after the business meeting.

The Criminal Law and Criminal Issues Initiative will present a joint program - "The Future of Michigan's Public Defense System: Free Fall, Free-for-All, or Fixed - Once and for All" - to discuss the state of public defense in Michigan.

The panel will include members of the prosecution and defense bar, a clinical law professor, justice system researchers and a sitting felony court judge, who will moderate the session. Please join us from 10 a.m. to 12 p.m. to discuss the future of our state public defense system.

### **10 a.m. – 12 p.m.: Criminal Law Section and Criminal Issues Initiative Joint Program**

“The Future of Michigan's Public Defense System: Free Fall, Free-for-All, or Fixed—Once and for All.” This program is offered on the heels of the National Legal Aid and Defender Association report, which concludes that Michigan fails to provide adequate legal counsel as mandated by the Constitution. Join stakeholders in discussing the future of how public defense services are delivered in Michigan. Formally meet the Michigan Campaign for Justice, a new nonprofit organization advocating for a fair and effective public defense system in Michigan.

In addition to our own meeting and program, the following events may also be of interest to our members:

Please join us in honoring Bruce A. Timmons, Criminal Law Section Legislative Counsel, who will receive the Frank J. Kelley Distinguished Public Service Award. The annual award was created to recognize extraordinary governmental service by a lawyer who: serves in the public sector in a way that strengthens our system of justice under the law; demonstrates the highest standards of integrity, fairness, leadership, excellence, dedication to principle and dedication to the ideals of democracy; and, has made a significant lasting contribution to the nation, state, or community in which s/he lives or serves. The award will be presented during the State Bar of Michigan Awards Banquet, which will be held on Wednesday, September 17, 2008 from 6:30 – 9:30 p.m.

The Justice Initiative will offer the following criminal law-related program on Thursday, September 18, 2008: “Incarceration or Graduation?” will be presented from 9 a.m. to 12 p.m. Juveniles most at risk of entering the “School-to-Prison Pipeline” often have emotional troubles, educational disabilities, or other mental health needs. Rather than receiving help in school they are passed on to the court system, a path that often leads to a future in adult prisons. Join the State Bar’s Equal Access Initiative and Michigan Protection and Advocacy as they host a panel of experts featuring special guest Ron Lospennato, Director, Southern Poverty Law Center’s School to Prison Reform Project.

The aforementioned programs are open to all members of the bar.

## United States Supreme Court – Cert Granted

**Bell v Kelly**, No. 07-1223 (May 12, 2008): Review was granted to determine whether the federal habeas provision governing claims adjudicated on the merits in state court, 28 U.S.C § 2254, should be applied to claims of ineffective assistance of counsel that the state court refused to consider.

**Arizona v Johnson**, No. 07-1122 (June 23, 2008): Review was granted to determine whether officers violated the constitutional prohibition against unreasonable searches and seizures when, after making a routine traffic stop, they searched an individual who was consensually conversing with them and was not suspected of committing any criminal offense.

**Cone v Bell**, No. 07-1114 (June 23, 2008): Review was granted to determine whether a federal habeas claim was procedurally defaulted because it had been twice presented to the state courts, and whether a federal court was precluded from recognizing that a state court erred in holding that state law precluded reviewing a claim that the prosecution suppressed exculpatory material contrary to *Brady v Maryland*, 373 US 83 (1963).

**Harbison v Bell**, No. 07-8521 (June 23, 2008): Review was granted to determine whether prisoners sentenced under state law are afforded the right to federally-appointed and funded counsel to pursue clemency under state law, and whether a district court's denial of such a request may be appealed without a certificate of appealability.

**Knowles v Mirzayance**, No. 07-1315 (June 27, 2008): Review was granted to determine whether, under federal habeas law, defense counsel's recommendation to withdraw an insanity plea constituted ineffective assistance of counsel.
