HB 4548 (Kosowski) Criminal procedure, evidence; Children, protection. Criminal procedure; evidence; consideration of videorecorded statements in certain proceedings; allow. Amends sec. 2163a of 1961 PA 236 (MCL 600.2163a).

HB 4549 (Santana) Children, protection; Courts, probate court; Criminal procedure, evidence. Children; protection; videorecorded statements; allow to be used in child protective services hearings, increase fines for improper release of, and require to be retained for certain period of time. Amends sec. 17b, ch. XIIA of 1939 PA 288 (MCL 712A.17b).

SB 0386 (Casperson) Traffic control, violations. Traffic control; violations; prohibition on courts taking under advisement certain offenses committed by a person while operating a commercial motor vehicle or a person licensed to operate a commercial motor vehicle while operating a noncommercial motor vehicle; reinstate. Amends sec. 732 of 1949 PA 300 (MCL 257.732).
