hether the practitioner is an experienced appellate advocate or a first-time filer, there are a number of helpful Michigan appellate practice resources—many available online.

Chapter 16 of ICLE's Michigan Basic Practice Handbook (6th ed), available at http://www.icle.org/modules/store/books/book.aspx?PRODUCT_CODE=2007553820, contains forms and a comprehensive discussion of the procedural steps for appeals to circuit court, the state Court of Appeals, and the Michigan Supreme Court.

ICLE's Michigan Appellate Handbook (3d ed), available at http://www.icle.org/ modules/store/books/book.aspx? PRODUCT_CODE=2013550510, is an expanded version with the same contributing editors and includes forms along with a discussion of the fundamentals of appellate review; preparing the case for appeal; authority, organization, and operation of the Court of Appeals; appeals of right in the Court of Appeals; appellate standards of review; interlocutory and discretionary review in the Court of Appeals; expediting review; motion practice; appellate briefs; amicus curiae briefs; oral argument in the Court of Appeals; decisions and post-decision practice in the Court of Appeals; applications for leave to appeal in the Supreme Court; calendar cases in the Supreme Court; appeals to circuit court; administrative appeals; and criminal appeals.
