The Shared Parenting Act was introduced June 1 without input from the section. HB 4691 makes significant changes to the Child Custody Act, imposing substantially equal parenting time on virtually every child and moving the focus from the child's interest to the parents'. Council voted to oppose the bill at its June meeting. The Parenting Solutions and Legislative committees will continue their work to allow family law attorneys to have a voice in this important legislation.
