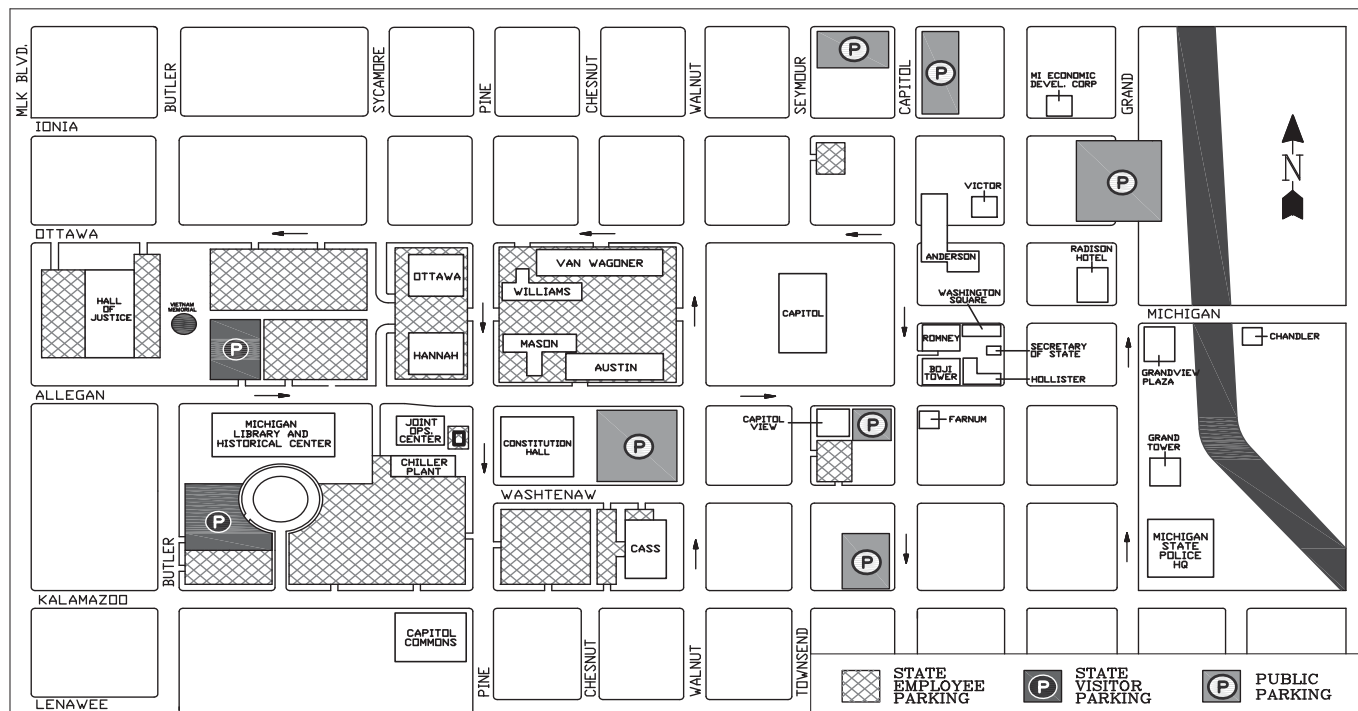

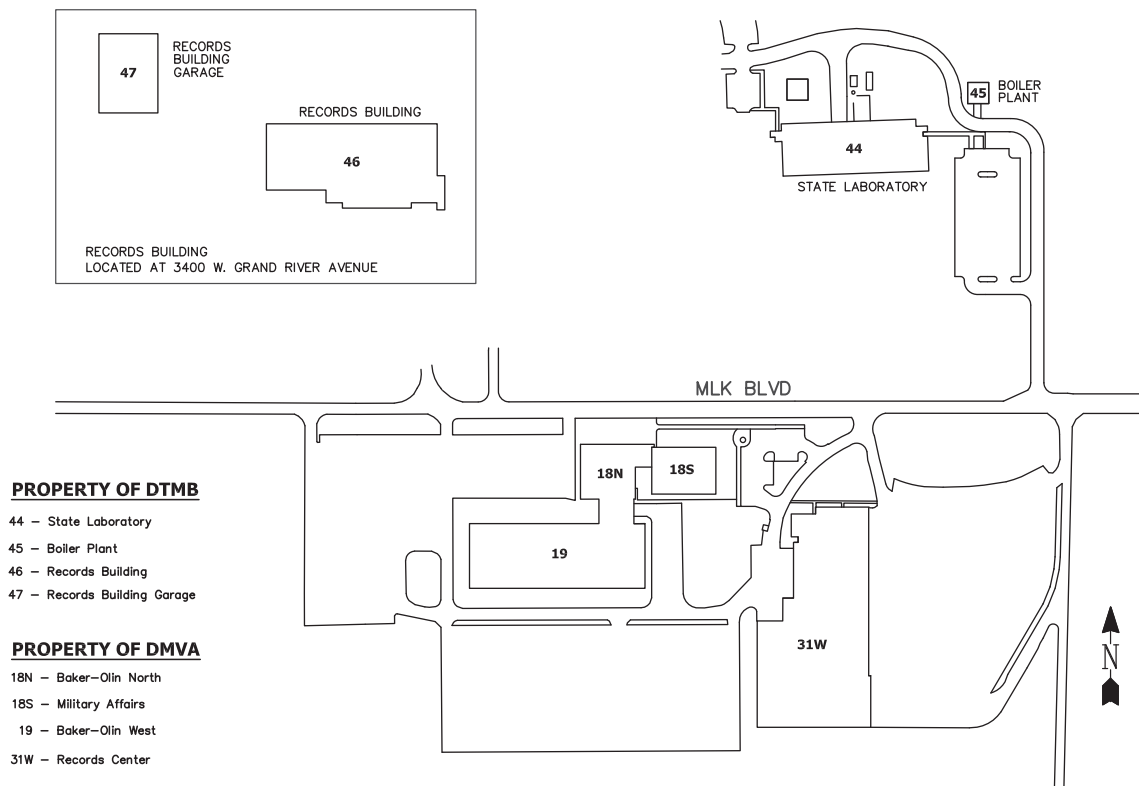
STATE OF MICHIGAN LANSING AREA FACILITY LOCATIONS

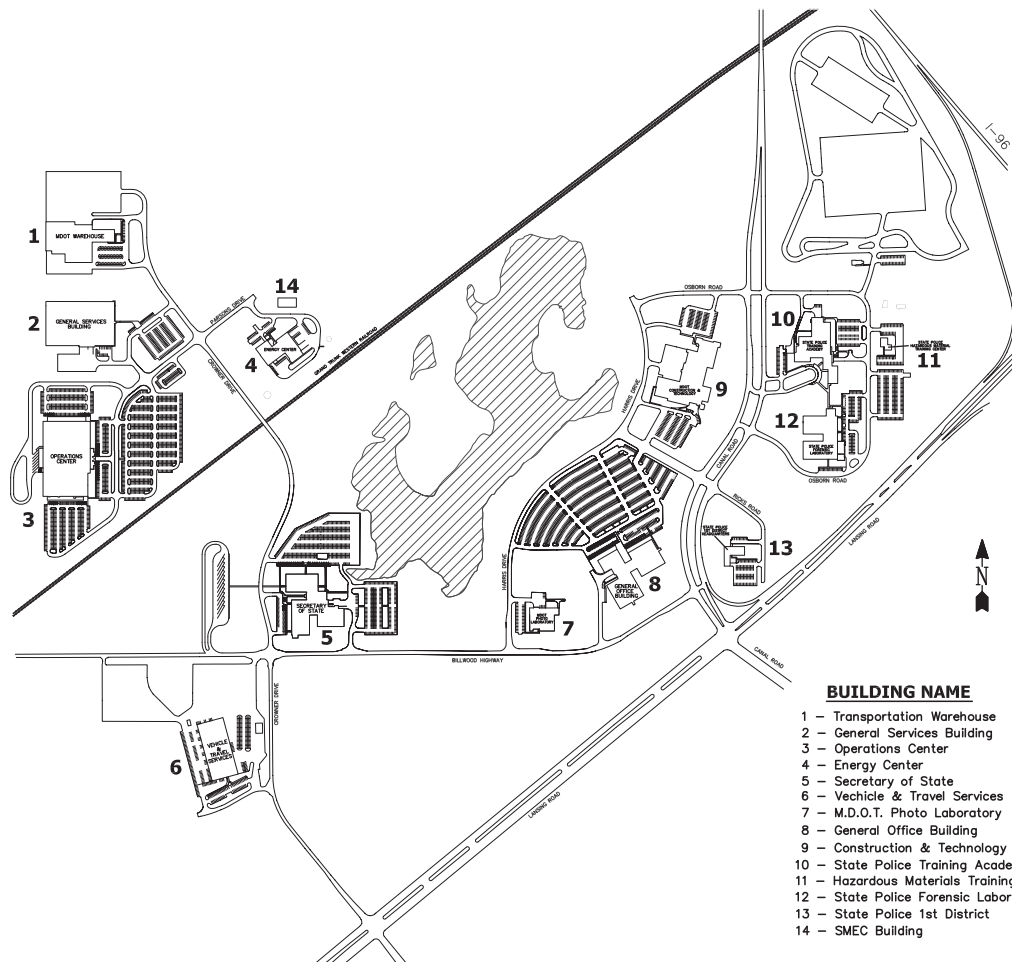
STATE OF MICHIGAN CAPITOL COMPLEX
