Support amendments to Rule 3.223 with additional language proposed by the Family Law Section to Paragraph (D) to provide the court with verification that the parties consent to the agreement, either by each party being present at the hearing or submitting a signed and notarized copy of the final judgment or order.

- (A)(1)—Only an individual natural person is eligible for the waiver or suspension of fees and costs under this rule. A private or public organization is not eligible for a waiver of fees unless an applicable statute provides that no fee(s) shall be required.
- (B)—The request must be on the a form approved by the State Court Administrative Office.
- (F)—Denial of a Request to Waive/Suspend Fees. A judge shall enter an order either granting or denying the request within one three business days.
- (G)—If a party is entitled to relief in an action for divorce...
