#### American Indian Law Section

The Michigan Supreme Court recently amended MCR 3.993 to make enforcement of key Indian Child Welfare Act and Michigan Indian Family Preservation Act provisions easier. Now, appeals by right are allowed for errors that would subject an order to reversal. For example, any order of removal of an Indian child that does not comply with ICWA/MIFPA can be directly appealed to the Michigan Court of Appeals without seeking leave to appeal.
