POSITION: Support the rule changes as a necessary first step in responding to the In re Ferranti decision; recommend the following amendments:

- The word "under" or some similar phrase should be inserted before MCL 712A.21, such that it would read: "... that at any time while the court retains jurisdiction over the minor, the respondent may challenge the continuing exercise of that jurisdiction by filing a motion for rehearing, under MCL 712A.21 or MCR 3.992, or by filing an application for leave to appeal with the Michigan Court of Appeals."
- The Court should clarify whether litigants should follow the time deadline set forth in MCL 712A.21 or MCL 3.992.
