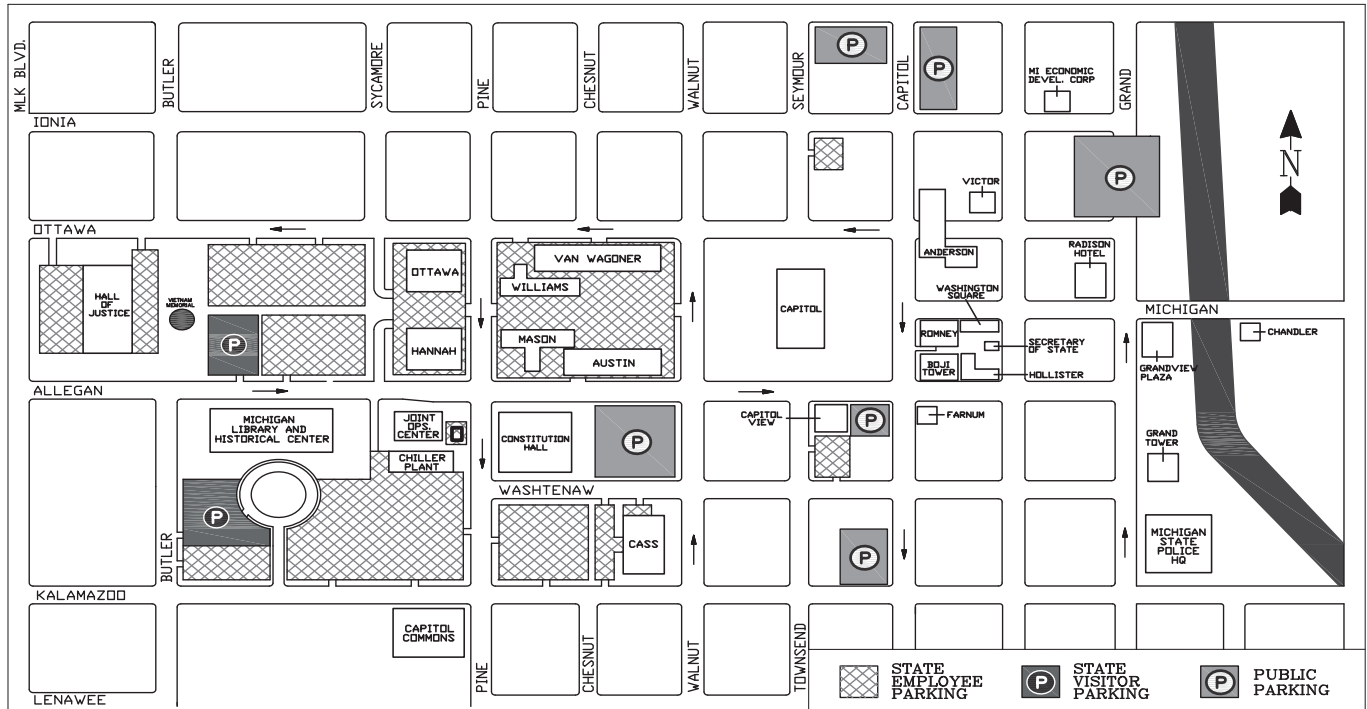

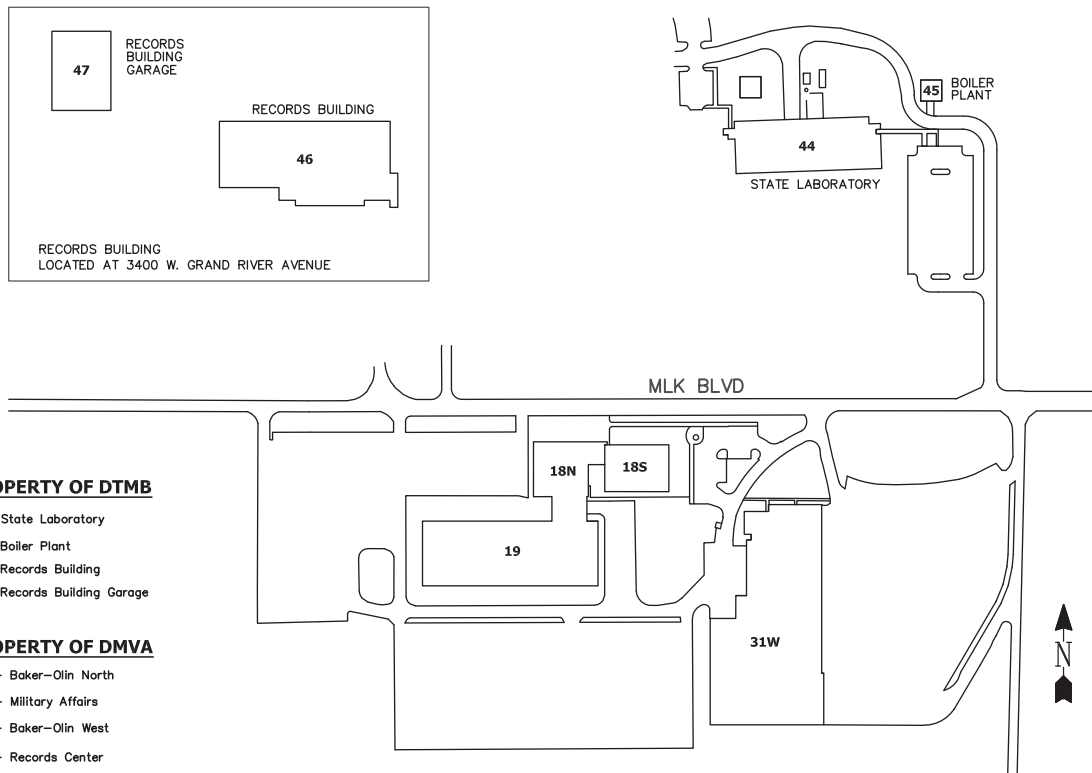

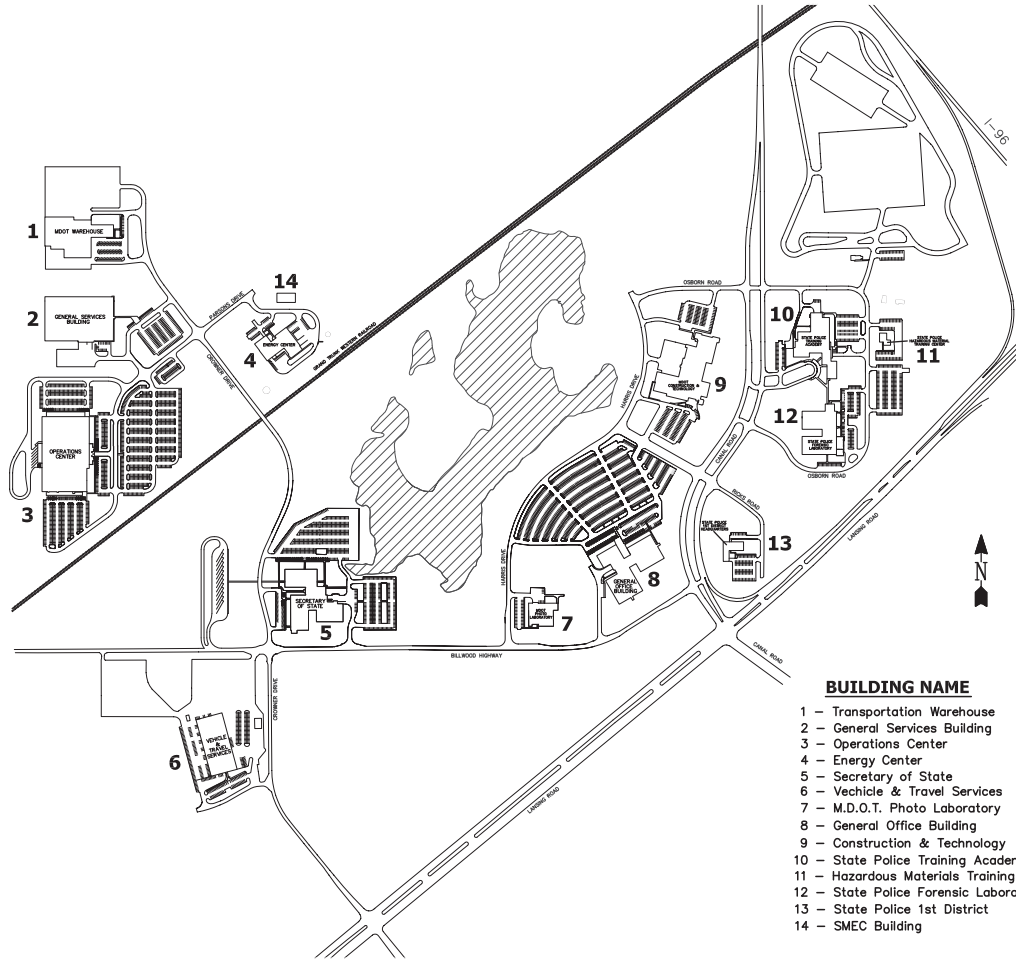
STATE OF MICHIGAN CAPITOL COMPLEX
