ADM File No. 2012-02 Proposed Amendment of Rule 2.302 of the Michigan Court Rules

The Board considered two versions of proposed amendments to MCR 2.302 regarding discovery-only depositions. Alternative A would clarify that discovery-only depositions may be taken only by stipulation or court order. Alternative A would also require that the stipulation or order explain how the costs of this type of deposition are to be allocated. This Alternative was submitted by the State Bar of Michigan Representative Assembly. The proposed amendments in Alternative B would allow any party to schedule a discovery-only deposition without the need to obtain stipulation of the other party or parties or approval of the court. A motion was offered and supported to reaffirm support for Alternative A. The motion carried.

ADM File No. 2014-08 Amendment of Rule 3.221 of the Michigan Court Rules

The amendment of MCR 3.221 strike the term "magistrate" from subsections (C) and (1) to clarify the rule because there is no statutory authority for district court magistrates to conduct bond review hearings on support and parenting time enforcement act bench warrants.

A motion was offered and supported to support this proposal. The motion carried.

Legislation

Expert Witness Testimony Concerning Chemical Testing

HB 5383 (Lauwers) Criminal procedure; evidence; expert witness testimony concerning chemical testing and custody of evidence by video communication; allow at preliminary examination and trial for certain prosecutions, and provide for release subject to conditions reasonably necessary for the protection of the public under certain circumstances. Amends sec. 1, ch. III, sec. 6b, ch. V & sec. 22, ch. VIII of 1927 PA 175 (MCL 763.1 et seq.).

SB 0863 (Pavlov) Criminal procedure; evidence; expert witness testimony concerning chemical testing and custody of evidence by video communication; allow at preliminary examination and trial for certain prosecutions, and provide for release subject to conditions reasonably necessary for the protection of the public under certain circumstances. Amends sec. 1, ch. III, sec. 6b, ch. V, & sec. 22, ch. VIII of 1927 PA 175 (MCL 763.1 et seq.). A motion was offered and supported to oppose this legislation. The motion carried. Commissioner Cunningham abstained.

HB 5415 (Forlini) Housing; landlord and tenants; notification of evictions; allow by electronic mail. Amends sec. 5718 of 1961 PA 236 (MCL 600.5718).

A motion was offered and supported to oppose this legislation because it does not contain sufficient safeguards ensuring receipt of notice by the tenant. The motion carried.

SB 0845 (Hansen) Criminal procedure; warrants; district court magistrate to issue an arrest warrant; allow. Amends sec. 1, ch. IV of 1927 PA 175 (MCL 764.1).

A motion was offered and supported to support this legislation. The motion carried.

Recommendation of the Committee on Justice Initiatives Civil Rights to Counsel Work Group

Urge the Board of Commissioners to approve the work group proposed by the Committee on Justice Initiatives to examine the issue of a right to counsel and underserved populations without taking any position on the ABA resolution.

Motion offered and supported to approve the work group proposed by the committee without taking any position on the ABA resolution. The motion carried.

Mr. Rombach has been approached by a number of State Bar members about an ad that is currently showing on television for the Ford Fusion. The ad contains a reference to "ambulance chasers." Because "ambulance chasers" is a derogatory stereotype for lawyers, it was suggested that a letter be sent to the Ford Motor Car Company registering an objection to the use of the term.

A motion was offered and supported to send a letter to Ford Company. The motion carried. Commissioners Costello, Brown, Gobbo, Pero, Riordan, Shovein and Williams abstained.

The Commissioners asked to review the letter before it is sent.
