### Westshore Dispute Resolution Center growing, moving to new site

The Westshore Dispute Resolution Center (WDRC), a nonprofit issues-solving agency, is growing, needs more space, and is moving to a larger facility in downtown Muskegon.

Beginning in mid-October, the agency will move from 8 West Walton—across

said **David Cotter**, the agency's director, who also announced his retirement. "(The Ransom Street building) is barrier-free. It's the expansion that we needed." Formed in 1994 to help residents of Muskegon, Mason, Manistee, and Oceana Counties, WDRC's highly

trained volunteers now handle 1,000 referrals a year.

The center has helped courts, lawyers and their clients from throughout West Michigan from its current location since 2002. There, a growing group of WDRC volunteers has dealt with feuding neighbors, divorcing parents, alienated grandparents—and dozens of other issues and individuals over the years.

WDRC's new facility will offer staff and clients more room to deal with restorative justice, domestic relations, small claims and other minor general civil matters. In the last six years, WDRC's caseload has quadrupled, Cotter said. While its 5-member staff has remained stable, volunteers are now at 50. "It's like a second career for some people," Cotter said.

## Vino, storia con honeymoon

Married on 7/7/07 (along with an estimated 65,000 other couples), Kathy and I decided to make another dream come true - travel to Italy on our honeymoon. We agreed to see the historic cities of Rome, Florence, and Venice and we finalized a 10-day itinerary just days before our departure. Ten days is not enough.

In The Eternal City of Rome, we visited St. Peter's Basilica, the Vatican Museums, the Sistine Chapel, the Roman Forum (i.e. "the ruins"), Trevi Fountain, Piazza Navona, the Pantheon, the Coliseum, Castel Sant'Angelo, the Spanish Steps, and the Galleria Borghese. All in just three days! The highlight of our Rome Adventure was our dinner cruise up and down the Tiber River taking in the glow of St. Peter's Basilica and the Castel Sant'Angelo at night. We were able to share the experience with a nice couple from England during our romantic 5course meal.

Florence greeted us with a 100-degree heat wave and high humidity on our fourth day. Viewing my namesake, the statue of "David" located in the Galleria dell'Accademia, was the highlight for me. For Kathy, it was shopping at Ferragamo, Ponte Vecchio, and the outdoor markets.

Our train ride to Venice acquainted us with a native Venetian. She taught for 30 years at the University in Venezia and was able to point us to the right vaporetto (water taxi) in order to find our hotel, "Al Ponte Dei Sospiri." It was a beautiful and elegant hotel, complete with Murano glass chandeliers, and a stone's throw away from San Marco Plaza and St. Mark's Basilica. One morning we toured the Galleria dell'Accademia in Dorsoduro and viewed paintings from the 13<sup>th</sup> through 18<sup>th</sup> centuries by Bellini, Tintoretto, and Carpaccio. The afternoon was spent window-shopping on the island of Murano, famous for its glass factories.

Venice offered the best pizza I've ever had at "Al Chianti." Other highlights: Walking the "golden staircase" at the Palazzo Ducale, seeing where most of the important decisions were made at the Doge's Palace, and meandering the streets and alleyways of Venice in search of the famous Rialto Bridge.

But when in Venice, a gondola ride is a must. Our gondolier, Mateo, picked us up at our hotel's water entrance and whisked us through parts of Venice that can only be seen by boat. He showed us Marco Polo's palace, Casanova's hideout, and a superb view of the Bridge of Sighs, built in the 17<sup>th</sup> century to connect the palazzo and the Courts of Justice to the prisons – thus the name. Prisoners condemned to death could be heard sighing as they passed over this bridge both on their way into prison and eventually on their way to execution in Piazzetta San Marco.
