
# MCBA agrees to host 'PIP-2' next August

## FLS speaker explains the intricacies of retirement planning

It all once seemed so simple: Reach retirement age, collect Social Security, tab your investments, live long and prosper. For those reaching retirement age today, the devil is in the details. First, when is retirement age — 62, 65, 66, later?

Jill VanTine, a Merrill Lynch representative, addressed these and related questions for the 19 October meeting of the MCBA Family Law Section.

The decision for some is to retire at 62, and take a 25% discount or wait until full retirement at 66 to achieve maximum benefit. There are other wrinkles, too: Wait until 67-70 and accrue an increase to your maximum benefit at 8% over the cost of living. What about taxes? Medicare and supplemental health insurance?

Attorneys practicing family law and estate planning must consider retirement assets for their clients. We, however, must also do our own planning by consulting professionals knowledgeable about financial planning—including Social Security and Medicare.
