The Managing Partners Diversity Collaborative of Grand Rapids (“MPDC”) has recently funded LSAT Scholarships for diverse students to pay for the cost of preparing for and taking the LSAT admission test.

An LSAT Scholarship includes: (1) an LSAT prep course provided by an approved test preparation service(e.g., Kaplan); (2) the LSAT test fee; and (3) the Law School Admissions Counsel Credential Assembly Service fees for providing LSAT reports to law schools.

To be eligible, an applicant should qualify under one or more of the categories of diversity:

“Race, ethnicity, gender, sexual orientation, gender identity and expression, religion, nationality, language, age, disability, marital and parental status, geographic origin, and socioeconomic background.”
