# **Master Lawyers Section**

#### Introduction

The State Bar of Michigan, through the Committee on Justice Initiatives and the Pro Bono Initiative, supports a number of opportunities for members of the legal community to give their time and resources to those who are unable to afford an attorney. The overall goal of the PBI is that every attorney and firm in the state has one or more opportunities available to them to fulfill their pro bono obligation. Our goal in developing this "menu" is to allow attorneys flexibility in serving the community by choosing the ways that best fit their individual skills and circumstances. We are especially pleased to let members of the Master Lawyers Section¹ know through this customized menu the range of pro bono opportunities that are particularly suited to their wisdom and experience. We encourage you to use this information to help you decide how you can help provide legal assistance in your community.

In 1990, the Representative Assembly adopted the Voluntary Standard for Pro Bono Participation. The Standard encourages lawyers to fulfill their pro bono obligation by providing 30 hours of service and/or donating \$300 to an organization providing free legal services to the poor each year. The two options—service or donations—are of equal value; both are necessary to address the lack of access to legal assistance.

In general, pro bono programs are not directly sponsored by the State Bar. Rather, these programs are sponsored by local legal aid programs, local and specialty bar associations, state and local advocacy organizations, and law school clinics. # Service Options for More Experienced Lawyers

# **Donation Option**

For many lawyers, providing pro bono service is not the best option. Those lawyers are encouraged to meet their pro bono obligation by contributing to the Access to Justice (ATJ) Fund.

The ATJ Campaign is a partnership of the State Bar, the Michigan State Bar Foundation, and the civil legal services programs in the state to raise money to support civil legal services throughout the state for low-income persons. Contributions to the ATJ Fund, administered by the Foundation, can be designated for a local program or for a statewide long term endowment. The guideline for financial giving established by the Voluntary Standard is a minimum annual monetary commitment of \$300. In 2006 the Representative Assembly adopted a guideline that lawyers who can afford to do so are encouraged to donate \$500 per year in lieu of pro bono service.

#### Conclusion

The two main goals of the Voluntary Standard are to provide guidance to lawyers about how they could meet their responsibility under Michigan Rule of Professional Conduct (MRPC) 6.1 and to describe a range of pro bono activities that will permit every lawyer to satisfy that obligation. Over time, lawyers and law firms and non-profit legal services providers have worked together to develop programs that offer a wide range of case types and practice setting to pro bono lawyers. The advent of the Master Lawyers Section offers an even greater opportunity to apply the skills of sections members to the unmet legal needs of the poor.

The need for representation in civil cases remains very great. We urge you to connect with one of these programs and to take advantage of one of these opportunities.
