#### **Bill Numbers:**

<u>HB 4763</u> (Schmidt) Traffic control, traffic regulation. Traffic control; traffic regulation; use of automated traffic enforcement safety devices at certain intersections; allow. Amends secs. 727c & 741 of 1949 PA 300 (MCL 257.727c & 257.741) & adds div. heading & adds secs. 751, 752, 753, 754, 755, 756, 757, 758, 759, 760, 761 & 762.

#### Explanation of the position, including any recommended amendments:

The committee opposes this bill for two key reasons: (1) This bill codifies automated traffic tickets and reinvents the civil infraction system as civil offenses; (2) There is concern as to the proposal putting an undue burden of context of the presumed offense on citizens. This position is based on those taken by the Michigan District Judges Association and the State Court Administrator's Office.

## Keller-permissible explanation:

The bill affects the functioning of the courts in that it reinvents the civil infraction system in a different way calling it civil offenses which would distribute money from fines in a different manner. Additionally, because the use of such devices would place heavy burden on the defendant for context, this could clog the courts.
