From our September 2006 touchdown in Sault Ste. Marie to begin the UP Tour to the time she put her gavel down a year later in Grand Rapids, Kim Cahill and I made over 80 visits to Michigan bar associations, with Kim leading the lion's share of those. Kim made my job a dream because she knew just about everything. She never said no to any request for help or opportunity for camaraderie. She was a model of confidence and independent style, she was generous in all ways, she was big fun, and she was just terrific. We all knew that. But then, her seemingly endless energy just, inexplicably, ended.
