<u>HB 4556</u> (Lipton) Juveniles; criminal procedure; juvenile competency standards; revise. Amends sec. 1, ch. XIIA of <u>1939 PA 288</u> (MCL 712A.1) & adds secs. 18n, 18p, 18o, 18q, 18r & 18s to ch. XIIA.

Status: 04/14/11 Referred to House Judiciary

Position for E-vote: Adopt the same position as the Criminal Law Section supporting the legislation but with a requested amendment that if a forensic mental health examiner is not available, the court should appoint another qualified person for the competency exam.

a. ADM File No. 2011-05 Proposed Amendments of Rules 1.1, 1.2, 1.3, 1.4, 1.5, 1.6, 1.7, 1.9, 1.13, 1.14, 1.15, 1.16, 1.17, 3.2, 4.1, 4.3, 5.2, and 8.4 of the Michigan Rules of Professional Conduct

The proposed amendments of MRPC 1.1, 1.2, 1.3, 1.4, 1.5, 1.6, 1.7, 1.9, 1.13, 1.14, 1.15, 1.16, 1.17, 3.2, 4.1, 4.3, 5.2, and 8.4 would incorporate language from the comments of these rules into the rule itself.

b. <u>HB 4472</u> (Pscholka) Corrections; parole; appointment of legal counsel for prisoner based upon appeal of parole by victim or prosecutor; prohibit under certain circumstances. Amends sec. 34 of <u>1953 PA 232</u> (MCL <u>791.234</u>).

Status: 04/14/11 Referred to House Judiciary

Position for e-vote: the committee votes to oppose the bill because it takes away the discretion of the judge in appointing counsel for the prisoner.

c. Michigan Supreme Court Terms Letter from Civil Procedure & Courts Committee

Position for e-vote: the committee votes to support the recommendation that the Supreme Court year be based on the calendar year.

d. Proposed MCL 712.A.11 – Consent Calendar

The committee will table the matter and wait to see the upcoming legislation.
