Dr. Johnson has been a long-time proponent of the legal profession, and this most likely has gone unrecognized at least by the State Bar of Michigan over the many years that he has done tremendous work in both exemplifying the benefits of education and promoting and educating numerous attorneys.

As a professor of law at Michigan State University College of Law, Dr. Jonson joined the law college faculty (at that time, the Detroit College of Law) in 1973, marking thirty-seven years of service in educating law students.
