



## State Bar of Michigan Member Privacy Policy

### Member Privacy Statement

The State Bar of Michigan understands the importance of member privacy and has safeguards in place to protect the information you provide us. Our objective is to assure your privacy while continuing to provide you with superior benefits and services. Our Member Privacy Policy describes the Bar's efforts to meet this objective.

### What Information Do We Collect?

In order to serve you and the public and meet our obligations under statute and court rule, we must collect and maintain accurate specific public and nonpublic information about you. We obtain this information from your mandatory Dues Statement and other forms you voluntarily submit to us.

#### Public Information

**Your name, P number, status, address of record and bar admit date are matters of public record.** In addition to this basic information, as a service to you and the public, your telephone number, fax number, and e-mail address will also be made public by publication in the directory issue of the Michigan Bar Journal and in the online directory, unless you specifically direct otherwise. Your membership in State Bar committees is also treated as public information, as is your membership in State Bar sections unless you specifically direct otherwise.

#### Non-Public Information

You are required by the Michigan Supreme Court to provide us with certain information relevant to the effective regulation of the legal profession, such as your birth date, admit date in other jurisdictions, method of admission, county of admission, law school and year of graduation, lawyer trust account information, other jurisdictions where you are licensed, and whether you carry malpractice insurance. This information is not public, and is not disclosed to third parties.

The Michigan Supreme Court also requires you annually to provide information about any disciplinary action taken against you in other jurisdictions, and criminal convictions. The State Bar does not retain this information; it is sent directly to the Attorney Grievance Commission and Attorney Discipline Board.

Nonpublic information collected by the State Bar is never disclosed except in the following very limited circumstances: as required by law; if necessary to comply with legal process served on the State Bar; to protect the State Bar's rights or property; or to take emergency action to protect the personal safety of users of the State Bar Web site or the public.

### Voluntary Surveys

To facilitate better communication and to aid in your practice, the State Bar periodically asks you voluntarily to provide information such as your practice type and firm size. No individual information collected for this purpose is ever disclosed to the public.

### **How is Member Information Used and Shared with Others?**

The State Bar uses your contact information in three ways: 1) to carry out membership and regulatory functions, 2) to advise you of State Bar activities and news, including from section and ICLE information, and 3) to advise you of external events and benefit offers from third parties that we have determined are of value to our membership. We provide you with the opportunity to opt out of communications in this third category.

### Special Provisions Concerning E-Mail Addresses

If you give the State Bar your e-mail address, we will use it periodically to send you important notices concerning the State Bar and messages about Michigan Law Online, a free Bar member benefit offered through the State Bar's CLE partner, the Institute for Continuing Legal Education (ICLE). We occasionally also make member e-mail addresses available directly to the legal community -- courts, ICLE, and local and special purpose bars - for their limited use only and on condition that they comply with our Member Privacy Statement. We do not provide e-mail addresses directly to any other source. When you give us your e-mail address you are agreeing to the use of your e-mail address for these purposes. If you decide later that you do not want to receive e-mail information from the State Bar or legal community, you may block future e-mails by contacting us to remove your e-mail address from our member records, including the public directories. If your e-mail address is removed from your record, you will not be able to participate in SBM eCommerce, including the ability to process your annual dues invoice online.

### Limited Sharing of Information with the Legal Community and SBM "Partners"

Upon request, the State Bar helps the legal community contact segments of the State Bar membership by providing address of record information in bulk format (address labels). The information is provided in this format for their limited use only and on condition that they comply with our Member Privacy Statement.

Your address of record may also be used to mail you offers and information from companies that perform support or marketing services on our behalf, such as mailing, market research and data processing or other institutions, or with companies with whom we have joint marketing or affiliated partner agreements. We review the information in advance before granting approval for the offer and do not permit mailings to any member who has requested to "opt out" of these mailings.

### **How Do We Protect the Confidentiality, Security and Integrity of Your Information?**

We maintain physical, electronic and procedural safeguards to protect the database of information we collect about you. Internally, access to our database is restricted to those State Bar employees who need access in order to serve you. Third parties who provide support services are required to conform to our safeguard standards.

If you see incomplete or erroneous information on your Dues Statement or elsewhere, you may complete an Address Change Form and send it to State Bar of Michigan, 306 Townsend Street, Lansing, MI 48933-2083, Attn: Member Services. If you have registered as an e-Commerce member, you will be able to correct your member information directly online.

### **How Can You Limit Sharing of Your Information?**

We respect your privacy and offer you choices as to whether we may share discretionary information about you with others. If you choose to opt out of communications from State Bar affiliated partners or third parties, you will not receive offers for products and services that could help you lower your costs or provide beneficial resources and information. If you do not initially choose to opt out, you may do so at any by contacting Member Records at (800) 968-1442.

You may notify us about your preferences at any time in writing. The Member Preferences Form can be found on the State Bar website at [www.michbar.org/generalinfo/](http://www.michbar.org/generalinfo/) or you can request one be sent to you by contacting Member Records at (800) 968-1442. If you have previously notified us, it is not necessary to do so again unless you decide to change your preferences. Your request will remain in effect until you notify us otherwise. We will honor your request and not share the information we collect about you with any parties outside the legal Community (see Member Record Policy). The preferences you provide through the annual dues notice, Member Preferences Form, or other communications will supersede previous preferences submitted to the Bar.

### Website Privacy Statement

The State Bar of Michigan is committed to protecting your privacy. We use the information we collect about you to process orders and to personalize your experience at our website. This privacy statement discloses the information gathering and privacy practices for our website.

### What information does SBM collect? How do we use it?

- **Dues Statement**  
The personal information required to complete a dues statement is determined by the Michigan Supreme Court for regulatory purposes. If you complete the dues invoice online, you will also be required to provide your credit card number and an expiration date so that we can process the invoice. Our use and protection of the information we collect from members from the dues statement and other sources is protected in accordance with our **Member Privacy Statement**.
- **Electronic Voting**  
To vote online in State Bar elections, you will need to enter your P-number and private PIN number provided with your ballot.
- **Online Orders**  
When you place an order from our website, we need to know your name, e-mail address, mailing address, P-Number, credit card number, and expiration date. This allows us to process and fill your order and to notify you of your order status.
- **Promotions, Online Surveys & Announcements**  
If you choose to participate in an online survey, subscribe to an e-mail list, enter a contest, or use one of our other promotional features, we may ask for your name, address, P-Number, e-mail address, practice areas, and other pertinent information to administer the contest, tabulate survey results, and subscribe you to lists. We will never use any personal information we gather from you for these purposes without your prior consent.
- **Browsing**  
SBM may use "cookies" for navigation of our online store and for customization of information we present to you. A "cookie" is a small text file that does not personally identify users, although it does identify a user's computer. "Cookies" do not pose a threat to your computer and they do not contain viruses. Most Web browsers automatically accept cookies, but you can change this feature in your browser.

## **How does SBM protect customer information?**

- When you place an order, we use a secure server to protect your sensitive information. The secure server software (SSL) encrypts all information you input before it is sent to us. Customer information is used to process and send order(s), bill credit cards, and to contact the customer when necessary. Unique identifiers (i.e., P-Numbers) are collected for use as account numbers in our record system.
- The use of all information provided by users of this website is governed by this Privacy Statement. In addition, information provided from members is used only in accordance with our Member Privacy and Website Policies, which may be viewed at: [www.michbar.org/generalinfo](http://www.michbar.org/generalinfo).
