

Q1 How long have you been a member of the Intellectual Property Law Section?




Q5 If you have attended the Summer Institute in the last five years, how many times?








Q8 How important is it to you that there are two IPLS seminar-type programs per year?

Q9 The Spring IP Seminar is held in March and the Summer Institute is held in July. Do you think that the dates are too close together?




Q10 If you think the dates are too close together, which would you prefer to see moved?


Q11 Please rate how valuable the Spring IP Seminar is to you.


Q12 How likely is it that you will attend a Spring IP Seminar within the next three years?

Q19 How likely is it that you will attend a future Summer Institute within the next three years?







Q22 How important is it to you that the Summer Institute be held at a resort/vacation destination





Q24 For the year that it is not on Mackinac Island, would moving the Summer Institute Iocation from Traverse City to West Michigan:



Q25 For the year that it is not on Mackinac Island, would moving the Summer Institute location from Traverse City to a different Northern Michigan location:





Q27 As compared to Mackinac Island, would you be more or less likely to attend the Summer Institute if it were held in either of the following locations?



Q28 As compared to mid-July, would you be more or less likely to attend the Summer Institute if it were conducted in the fall?




