Durable power of attorney law changes: Public Act 141 of 2012 amended Section 5501 of EPIC (MCL 700.5501) to impose a number of changes including witnessing requirements, explicit obligation of the attorney-infact, and a signed acknowledgement by the attorney-in-fact as to stated obligations and certain limitations. These changes take effect October 1, 2012. If you draft durable powers of attorney, you should read the act.
