Office. The patent office, named for the famed inventor for whom the phrase "the real McCoy" was coined, officially opened in Detroit the next morning following a rib-

bon cutting ceremony. It is the country's first satellite of the United States Patent and Trademark Office. ■

Cooley Summer Institute Growing

Former State Bar of Michigan President Reginald M. Turner Jr. (second row, center) was the keynote speaker at the recent closing of a month-long College Pre-Law Summer Institute at the Thomas M. Cooley Law School Auburn Hills campus. The goal of the summer institute, which has been in existence for three years, is to help diversify the legal profession by providing more than 100 hours of free law school instruction in torts, logic, critical reasoning, legal writing, and trial advocacy to low-income and disadvantaged students and students of color. So far, the program has served approximately 60 students from around the country; this year, 17 students successfully completed the

sessions. The summer institute is a partnership of the ABA Council of Legal Education Opportunity, Thomas M. Cooley Law School, Oakland University, and Kaplan Test Prep Services. EEOC Seminar Examines Disability Rights

Commissioners Victoria Lipnic and Chai Feldblum from the Equal Employment Opportunity Commission were in Detroit recently as part of a six-city tour to share knowledge and find solutions to discrimination in the workplace. They focused on equal employment and disability rights to help employers, attorneys, and human resources personnel identify discrimination in the workplace and implement remedies. The EEOC commissioners, both of whom were appointed in 2010 by President Obama, presented the Detroit Special Topics Seminar at the Westin Book Cadillac. The keynote speaker was Richard Bernstein, who spoke about the importance of inclusion by describing his experiences as a blind attorney. ■
