

A former association executive and university student affairs staff member, Jeffrey Cufaude is an architect of ideas, building communities of ideas and idealists through his writing, facilitation, and speaking. Currently he is working on his first book, Say Yes Less: Why it Matters and How to Do It. His areas of work include strategy think tanks that bring fresh eyes and innovative thinking to critical questions; conference workshops; volunteer and staff sessions and retreats; and major keynotes, including speaking on lifelong learning at TEDxIndianapolis in 2012. For 10 years, he led the American Society of Association Executives Future Leaders Conference, demonstrating his unique gifts in custom-designing and facilitating multiple-day leadership and learning experiences. His work is known for reflecting best practices in adult learning, and he often teaches presentation design and facilitation skills to subject matter experts. He also is an accomplished author with more than 20 articles published in major association magazines and journals. He is a long-time volunteer with several professional associations, was a co-producer of TEDxIndianapolis in 2013, and has served on the boards of several Indianapolis nonprofits including Big Car, an innovative arts and placemaking organization.
