Process used to take the ideological position:

The Prison and Corrections Section has an attorney membership of about 145 and the Section's governing Council is empowered by the Section's bylaws to take public policy positions. This policy position was adopted, after due notice, at a February 7, 2004 meeting of the Section's Council at which time nine (9) Council members were present. The vote was 9 Yes, 0 No.

Number who voted in favor and opposed to the position:

At the time of the February 7, 2004 meeting of the Section's Council, nine (9) voting Council members were present. The vote was 9 Yes, 0 No.

Statement of Opposition to House Bill 5170 and House Bill 5199

Prison and Corrections Section of the State Bar of Michigan

Disclosure pursuant to State Bar bylaws and Michigan Supreme Court Administrative Order 2004-1: The Prison and Corrections Section is a voluntary section of the State Bar, not the State Bar itself. The position expressed here is that of the Section's governing body. The State Bar has no current position on HB 5170 and HB 5199. The Prison and Corrections Section has an attorney membership of about 145 and the Section's governing Council is empowered by the Section's bylaws to take public policy positions. This policy position was adopted, after due notice, at a February 7, 2004 meeting of the Section's Council at which time nine (9) Council members were present. The vote was 9 Yes, 0 No.

The Section is opposed to HB 5170 and HB 5199 because the Bills create mandatory sentencing and bail schemes and, thus, unduly and severely restricts the discretion of the judge, prosecutor, and defense attorney. The blanket treatment of all offenders who may have different situations is bad public policy. The Section is supportive of the current criminal justice system, where the advocates fulfill their constitutional obligations and judges exercise discretion so that the sentence or bail is fair and appropriate to the circumstances of the individual offender, and proportionate to the offense.

The Section is further opposed to the House Bills because the legislation would act to further exacerbate the twin problems of crowded prisons and jails and the financial crisis caused by an expanding prison and jail population.
