

## CHANGE OF CURRENT ADDRESS FORM

For Michigan Bar Applicant Use Only

Your answers on the Affidavit of Personal History are considered as continuing to be true until the date of your admission to the State Bar of Michigan. If any answer or portion of an answer ceases to be true, you have a continuing obligation to immediately inform the Standing Committee on Character and Fitness. All updates must be submitted in writing. **This form must be used to notify the Character & Fitness Department of a change in your current address.**

### ADDRESS OF RECORD

The **State Bar of Michigan** will mail correspondence to the applicant's **current** address (F-3/Affidavit of Personal History, Question 2). Additionally, for routine inquiries, the Character & Fitness staff may use the e-mail address provided on the Affidavit of Personal History, (Question 3).

### FORM INSTRUCTIONS

This form is a fillable PDF, therefore, all submissions **must be typed**.

1. Enter the **DATE** of submission.
2. Enter your 5-digit **APPLICANT NUMBER**. This information is helpful, but not required. If you have not received a "status" letter or other correspondence from the Character & Fitness Department, you may leave this blank.
3. Enter your **FULL NAME**: First, Middle, Last, Suffix (if applicable).
4. Enter your **EMAIL** address only if it is different than what you entered on the Affidavit of Personal History (Question 3).
5. Enter your **HOME TELEPHONE NUMBER** only if it is different than what you entered on the Affidavit of Personal History (Question 3).
6. Enter your **CELL TELEPHONE NUMBER** only if it is different than what you entered on the Affidavit of Personal History (Question 3).
7. Enter your **FORMER ADDRESS** including dates of residence. (This is the address submitted on the Affidavit of Personal History (F-3), Question 2, or other address change, whichever is most recent.)
8. Enter your **NEW CURRENT ADDRESS**.
9. **SUBMIT** this form to the Character & Fitness Department via e-mail **OR** regular mail (not both).
