You can visit <http://www.michbar.org/memberdirectory> to view your record.


If you need to add or change your e-mail address on record, you can complete an online form for immediate access to the Member Area. See instructions below.

For those with a valid e-mail address on record, you can request to have your login information e-mailed to you by supplying your e-mail address or P#. When the e-mail arrives with your login and password information, return to the Login screen and enter that information.

If don't have an e-mail address on record or if it is incorrect, click the "If your e-mail address has changed" link and follow the directions for changing or adding an e-mail address. Once you have added an e-mail address of record, a password will be e-mailed to you.

Once logged in, use the blue links on the left to navigate the site.

If you prefer, you can update your e-mail address by fax or mail. Visit <http://www.michbar.org/programs/pdfs/AddressChange.pdf> and complete the contact information change form. Within two business days of receipt, your member record will be updated with your e-mail address.
