## Explanation of the position, including any recommended amendments:

HB 5987 is a companion bill to HB 5986 and modifies the Probate Code to provide for an automatic termination of grandparenting rights of a grandparent convicted of criminal sexual conduct against a child, or a sibling of a child, involving penetration, attempted penetration, or assault with intent to penetrate. The bill's language addresses CSC against "a child" which is not limited to the perpetrator's grandchildren. If this is the intent, the language "or a sibling of a child" isn't necessary, and would apply the termination of grandparenting rights even in the victim was not a minor, if the victim had a sibling who was a child.

The Family Law Section has several technical concerns with the bill. The bill requires the judge imposing a sentence in a criminal sexual conduct (MCL 750.520a et seq.) case to terminate the perpetrator's grandparenting rights. This provision will be found in MCL 712A.19b of the Probate Code, where neither the prosecutor, defense counsel, nor

the judge is likely to see it. This provision should be moved to the criminal code, or at least referenced there. The termination order should also be placed in any pending case involving the grandchildren in the family court. The Family Law Section opposes this bill until these technical amendments are made.
