Position:

The Criminal Law Section of the State Bar of Michigan supports in principle the expansion of jury lists to include as many eligible persons as possible, including persons registered to vote and persons who receive tax refunds, unemployment benefits, public assistance, or any other public benefit.

The Criminal Law Section of the State Bar of Michigan supports allowing courts the discretion to balance jury pools by the geographic location of potential jurors' residences, or other non-gender or race specific criteria.

Explanation of the position, including any recommended amendments:

There was recognition of the technical difficulty in merging such lists, but it was determined that this was better left to others and that the Section should endorse the goal of the proposed legislation. The view is based not only upon the rights of an accused, but also the integrity of the process. The justice system cannot function well when the citizenry does not believe in it.
