#### **Bill Number:**

HB 4931 (Lemmons) Courts; juries; lists of persons available for creating juror pools; expand. Amends sec. 1304 of 1961 PA 236 (MCL 600.1304) & adds secs. 1310a, 1310b, 1310c & 1310d.

<u>HB 4932</u> (Lemmons) Courts; juries; names and addresses of persons receiving unemployment benefits; allow to be disclosed to jury boards for selecting jury pools. Amends 1936 (Ex Sess) PA 1 (MCL <u>421.1</u> - <u>421.75</u>) by adding sec. 54d.

<u>HB 4933</u> (Lemmons) Courts; juries; names of persons receiving public assistance; allow to be disclosed to jury boards for selecting jury pools. Amends sec. 64 of <u>1939 PA 280</u> (MCL <u>400.64</u>).

<u>HB 4934</u> (Lemmons) Courts; juries; names and addresses of taxpayers; allow to be disclosed to jury boards for selecting jury pools. Amends sec. 28 of <u>1941 PA 122</u> (MCL <u>205.28</u>).

<u>HB 4755</u> (Cushingberry) Courts; juries; names and addresses of taxpayers; allow to be given to jury boards for purposes of selecting juror pools. Amends sec. 28 of <u>1941 PA 122</u> (MCL <u>205.28</u>).

<u>HB 4859</u> (Cushingberry) Courts; juries; jury pool selection process; revise. Amends secs. 1304, 1312 & 1321 of <u>1961</u> <u>PA 236</u> (MCL <u>600.1304</u> et seq.) & adds secs. 1301c, 1310a & 1310b.

# Explanation of the position, including any recommended amendments:

CJI supports the above bills to expand juror pools and obtain more diverse membership. CJI urges the Bar to participate in a workgroup or any other process which allows ways to address the following concerns: (1) because some people on some kinds of public assistance are not actually citizens of the United States, there is the possibility of a mistrial, if a non-citizen was on a jury; (2) individuals may be on the lists multiple times, (3) low income persons on public assistance, especially in rural areas, often have greater difficulty in finding reliable and affordable transportation to the courthouse, (4) a number of people on public assistance have disabilities or limited literacy that will make it difficult for them to read and/or respond to jury duty notices. We are concerned that such individuals may find themselves held in contempt for failure to appear, and; (5) persons with outstanding violations such as unpaid parking tickets, etc. be protected from prosecution during their participation in jury pool selection or jury duty.
