SB 0160 (Anderson) Civil rights; open meetings; catastrophic claims association; make subject to open meetings act. Amends secs. 2 & 3 of 1976 PA 267 (MCL 15.262 & 15.263).

SB 0161 (Anderson) Insurance; no-fault; catastrophic claims association; revise membership, require annual audit, make subject to open meetings act and freedom of information act, and provide for other general amendments. Amends secs. 134 & 3104 of 1956 PA 218 (MCL 500.134 & 500.3104).
