2010-2011

The Alternative Dispute Resolution (“ADR”) Section began its fiscal year by surveying its members and affiliates regarding their needs and expectations. The ADR Council’s intent was to discover what activities members and affiliates thought were important to them as practitioners and to find out how effective the ADR Section was in accomplishing certain activities.

The results of the survey served as a basis for planning the agenda of the ADR Council for fiscal year 2010 – 2011. Based on the survey results members and affiliates felt the following activities were very important to them:

- Provide educational training for ADR providers
- Provide skill building training for ADR providers
- Provide information to the public about the value of ADR
- Work with courts to increase the use of ADR

In addition to the ongoing work of the various actions teams of Judicial Access, Membership, Nominating, Publications, Section to Section and Skills, the ADR Council felt that given the results of the survey and the current environment in the state of Michigan, there were real opportunities to introduce the use of ADR processes as a means of resolving and preventing disputes, as well as facilitating change within the executive, legislative and judicial branches of State government. With this in mind, the ADR Council established the Governmental Task Force, with its mission to introduce the various branches of government to the positive aspects that ADR processes can bring to the table.

Governmental Task Force -- Over the last few months members of the Governmental Task Force have fanned out and met with the key players in the executive, legislative and judicial branches. Meetings have been held or are scheduled with the following State departments and agencies.

- Agriculture
- Attorney General
- Natural Resources & Environment
- Tax Tribunal
- Treasury
- Counsel to the Supreme Court
- House and Senate Chairs of the respective Judiciary Committees
- Legal Counsel to the Governor

As a result of these discussions, there have been overwhelmingly positive responses by the departments and agencies. Most agencies and departments see the value of using ADR processes to move agendas forward and do so in cost-effective ways. For the

MEETINGS, ACTIVITIES, AND SEMINARS: This is critical information for the Annual Report. Describing meetings, activities and seminars can be detailed, or brief. Suggestions for information to include are the date, location, and a minimum of one paragraph describing the event.

SECTION LEGISLATURE AND POLICY: The Section's involvement in legislature, policy, or *amicus curiae* is a matter of great interest, many questions are asked regarding the Sections involvement in such. A brief description of any such involvement is requested, as this falls under the heading of section activities.

AWARDS: Many Sections present awards, honors, or scholarships. The Annual Report is another opportunity to laud the recipients, as well as detail any awards presented to the Section itself. A description of the history of the award, or why the award is given, is useful.

FINANCIAL REPORT: Section finances vary from simple to complex. A brief statement of general budget information would be very appropriate to include in any Annual Report, or a reprinting of an annual Treasurer's report if the Section feel it is necessary.

Legislative issues: 1Q 2011, we examined and discussed ADM File No. 2008-18, proposed amendment to Rule 3.501 of the Michigan Court Rules. Ultimately, the Council members decided that the Section could not provide an official position.

On March 18, 2011, writing on behalf of myself, I sent a letter to Hon. Robert P. Young, Jr., Chief Justice and Elizabeth Lyon, Director of Governmental Relations, State Bar of Michigan, expressing opposition to ADM File No. 2008-18. On May 17, 2011, the Supreme Court issued an Order, after accepting public comments and listening to statements provided on May 11, 2011, declining to adopt either proposal and the file was announced closed without further action.

Recommendations for next Council: (1) Promote awareness of the Section and the scope of "Trade Regulation;" (2) increase the participation of inhouse counsel; (3) develop relationships with other Midwest state Bar antitrust sections and/or overlapping ABA Antitrust Section members, and (4) possibly consider expanding into electronic media, e.g., Linked-In Group.

Commercial Litigation Committee

The Commercial Litigation Committee assists litigators as well as business and corporate counsel in addressing issues that may lead to or arise in business-related litigation. The Committee sponsors seminars and other programs that address such issues and that are designed to enhance the practice of those involved in commercial litigation.

Corporate Laws Committee

The Corporate Laws Committee monitors and reviews matters relating to corporate law statutes and developments in the law of corporate governance. The committee also works with the Business Corporation Act Revision Subcommittee, which reviews the Michigan Business Corporation Act for the purpose of keeping it current with developments in corporate law and which assists from time to time in drafting and advocating proposed changes to the Act.

Debtor/Creditor Rights Committee

The Debtor/Creditor Rights Committee focuses on issues of insolvency, such as bankruptcy, state law alternatives to bankruptcy, secured lending (Article 9 of the Uniform Commercial Code), and state law exemptions.

Financial Institutions Committee

The Financial Institutions Committee focuses on legislative, regulatory and judicial developments and issues of interest to financial institutions (primarily banks) and their affiliates.

In-House Counsel Committee

The In-House Counsel Committee is committed to addressing the professional interests of in-house counsel by sponsoring continuing legal education programs, informing members about issues of particular interest to them, and offering social and professional networking opportunities.

Law Schools Committee

The Law Schools Committee is designed to promote an interest in business law among students at each of the law schools located in Michigan. The Committee represents a collaborative effort between the Section and the business law societies at the University of Michigan Law School,

Michigan State University College of Law, University of Detroit Mercy School of Law, Wayne State University Law School, Thomas M. Cooley Law School and Ave Maria School of Law. Nonprofit Corporations Committee

The Nonprofit Corporations Committee's principal responsibility is to review and update laws relating to the organization of nonprofit corporations in Michigan. The principal focus has been on the Nonprofit Corporation Act, but it also reviews other legislation, such as bills regulating the solicitation of contributions by charities. The committee also assists with sponsoring continuing legal education programs directed at nonprofit organization issues.

Regulation of Securities Committee

The Regulation of Securities Committee is concerned with federal and state laws and regulations relating to the offer, sale and trading of securities. The Committee also supplies a liaison to the Securities Law Advisory Committee of the Michigan Corporation & Securities Bureau. Activities are designed to inform members of current developments and issues and provide input to appropriate administrative and legislative bodies.

Uniform Commercial Code Committee

The Uniform Commercial Code Committee monitors developments and issues under all Articles of the UCC and related commercial statutes. In October of each year, the Committee presents a seminar on recent developments in commercial law. Additionally, the Committee prepares an annual survey of case law involving the UCC and commercial law.

Unincorporated Enterprises Committee

The Committee remains active in conducting seminars regarding unincorporated enterprises, focusing principally on limited liability companies. The Committee has also assisted in informing members of the bar from other sections as to legislation affecting unincorporated enterprises. Membership in the Committee is open to all members of the Business Law Section. The focus of the Committee's activities has been to present seminars in conjunction with ICLE and the Business Law Section. Membership and the opportunity to play a significant role in the Committee's activities is and will continue to be open to all members of this Section. As with most other committees, the Unincorporated Enterprises Committee schedules meetings primarily in the Western region of the Detroit metropolitan area. Legislative issues: This has been a very active year reviewing proposed legislation that has come before the Council. Following is a highlight of the some of the legislation we supported. For a complete list, please refer to our website.

We have supported video recording of custodial interrogations though some members did not feel the legislation went far enough. We support revising the expungement statute so that more individuals would be eligible. We also supported in principle changes in SORA legislation (Sex Offender Registration Act) as a move in the right direction. We also supported a change in legislation and court rules that permit both the prosecutor and defense counsel to retain a copy of the presentence report in their file following sentencing. Finally, we recommended in principle an effort to establish legislative guidelines for competency to stand trial for juveniles stressing the importance of having the examination conducted by a qualified forensic examiner.

Recommendations for next Council: The Council decided to add a seminar that would have a lower cost and emphasize basic legal training especially for new lawyers. It is our hope that such a seminar can be in place during our next fiscal year. The Chair had also asked that the Council consider the advantages of having a lobbyist to act on legislation that, through the Council, has a consensus among section members. However, the possible cost of a lobbyist and our current budget issues have left this issue for future Councils to address.

Other Information: This has been a productive year. Our annual program had very good attendance again this year with a lively program. The Shanty Creek program continued to see an increase in numbers. The bi-annual policy conference is expected to be another great program entitled Making Michigan’s Medical Marijuana Act Work.

We also were able to move forward on a number of long-standing issues that have been on our agenda for a number of years. We completed our revision of the bylaws which will be recommended to our section members at the annual meeting. We made the move to an electronic newsletter. For the first time, we adopted of two-year budget solidifying our financial situation.

We took on some new challenges by exploring the addition of a more cost-effective seminar for young lawyers focusing on the more practical aspects of the law. We discussed methods for increasing our membership and making our section a more effective organization.

Finally, and sadly, this year also saw the loss of one of our Council’s own members with the passing of Jerry Surowiec. He will be missed by all!

Legislative issues: The Family Law Council reviews all legislation affecting the practice of family law. We continued to retain the lobbying services of Bill Kandler, at Cusmano, Kandler & Reed, and he effectively assisted us with advocating our policy positions. He is assisting us in seeking a sponsor for revision to the Domestic Relations Arbitration Act.

The detailed statement of position on particular legislation is available on the Section's page of State Bar web site under Advocacy. The Legislature has been focused on budget issues, leading to less domestic relations legislation. We have supported the second parent adoption bill HB 4249, and several bills to allow standing in certain circumstances for biological fathers of children born during a marriage, HB 4067, SB 256.

We will consider HB 4414 and SB 257, requiring County Clerks to investigate the citizenship of people applying for marriage licenses. We will also review HB 4672 & 4673, codifying part of the law of marital property.

The Council has adopted the recommendations of the Legislative Committee.

Committee Activity: The Section has many active committees, most of which meet by phone conference. The dates and times of Committee meetings are available on the Section calendar viewable from the Family Law web page on the State Bar web site. Some of the significant activity this year is as follows:

Alternative Dispute Resolution: Chaired by Antoinette Raheem. Conference calls are held at 8 a.m. on the last Monday of each month. The committee (along with the Legislative Committee) analyzed the Uniform Collaborative Practice Act (UCLA), suggested modifications to it appropriate for Michigan, and engaged the services of our lobbyist to promote adoption of the UCLA by the Michigan Legislature. The committee also helped to organize, financially supported and provided judges to the Midwest Regional Mediation Competition (which included participants from 5 states and 2 countries). The committee has organized focus groups to meet this summer in nine (9) regions of the state to bring family law section members together to identify key ADR issues on which our section should focus. The Chair of this committee is representing the Section on a Supreme Court Committee convened to propose changes in the State's Mediator Ethics or Standards of Conduct. The Committee recommendations adopted support of proposed Collaborative Practice Act; support of Regional Mediation Competition. Doug Van Epps (SCAO) is the key contact to communicate with Council, the State Bar or others. Ron Bookholder and Toni Raheem hold the committee minutes and documents. The Chair can be contacted if there are issues related to the Family Law ADR that need be addressed by committee or council.

Amicus: Chaired by Liisa Speaker. This past year, the amicus committee has submitted an amicus brief *In re Beck* (child support and termination of parenting rights case) and will be submitting an amicus brief *In re Mays* (single parent doctrine) before the end of the fiscal year. The amicus committee also took over writing the case summaries for the Family Law Journal.

Court Rules: Chaired by Anne Argiroff and James Harrington, III. The Court Rules Committee met on a monthly basis through-out the 2010 – 2011 year, discussing proposed amendments to court rules and recent amendments and issuing recommendations on proposed amendments to the Family Law Council. The Committee issued numerous recommendations, which were adopted by Council, and forwarded to the Supreme Court. The committee also worked on its own proposals related to domestic relations court rules and commented on other proposals, including those involving changes to the default judgment court rule.

Domestic Violence: Chaired by Rebecca Shiemke and Donna Mobilia. The Domestic Violence Committee met several times by teleconference. The committee reviewed and commented on proposed new SCAO forms for sexual assault PPOs and generally approved of the SCAO's plan to adopt and issue new forms. The committee posted two power points on the Section website. The first is a power point on the dynamics of domestic violence developed by the committee and the second a power point from the ICLE training in July 2010 on Domestic Violence in Child Custody Cases. Finally, the committee discussed possible legislative initiatives to strengthen protections for domestic violence victims and will investigate these over the next year.

Family Court Forum: Chaired by Barbara Kelly. The committee planned the 12th annual interdisciplinary seminar to be held on June 10, 2011. This year's seminar will focus on examining joint legal custody.

Family Law Journal: Chaired by Lorne Gold and Antoinette Raheem. The Section continues to explore the possibility of making the Journal available to members electronically as an alternative to a paper copy.

Family Law Pact: Chaired by Neil M. Colman. Between October 1, 2010 and May 9, 2011 FAMILY LAW PAC has received generous contributions from attorneys of the Family Law Section totaling \$3,300. FAMILY LAW PAC continues to support legislators who are instrumental in addressing the concerns through legislation which affect the practice of family law.

Legislation: Chaired by Kent Weichmann and Barb Kelly. This very active committee meets monthly by phone conference and reviews all legislation in this area of the law. The Legislative Committee meets on the Thursday immediately preceding each Council meeting. See comments above on legislation for more detail.

QDRO/Taxation: Chaired by Joe Cunningham and Bob Treat. The committee has provided training to various legal aid attorneys throughout the State and members of the private bar who are willing to draft QDROs pro bono, providing a much needed service to the population of clients who cannot afford these critical orders.

Technology: Chaired by Liz Sadowski. Liz Sadowski continues to manage the Family Law ListServ, a very helpful online resource on family law issues.

Section Membership: Section membership increased this year, and it remains one of the largest Sections of the Bar with approximately 2,486 members. The Section continues to try to provide services to its members to assist in their practice and to that end held member forums with local associations seeking input.

Section Bylaws: Section 3.8 Council Vacancies was added to the Family Law Section Bylaws this year. Section 3.8 states “If a Council seat becomes vacant, after reasonable notice to Section members, the vacancy for that seat shall be filled by a majority vote of Council members at a regularly scheduled monthly meeting, until the next annual meeting. At the annual Council meeting there shall be a single election for all open Council seats. The highest vote recipients, in descending order from highest to lowest, shall be elected first to the open three (3) year seats, and thereafter open two (2) year seats and thereafter the open one (1) year seats. However, a Council member who has resigned or been removed from Council may only be elected to finish out the remaining term of that Council seat, and may not be elected to any other open Council seat at that election.”

Section 4.1 was amended to the Family Law Section Bylaws this year. Section 4.1 states “[e]xcept as provided in 4.3, the officers of the Section shall be elected by the Council from among its elected members *in the following order: (1) Recording Secretary (2) Corresponding Secretary (3) Treasurer (4) Chair-person Elect. No officer shall serve in their elected position for more than one full year or longer than the annual meeting*”.

Special Honors/Lifetime Achievement Award: Justice Marilyn J. Kelly is awarded the Lifetime Achievement Award. She will be honored at the annual dinner in September 2011.

Section Activities:

The Master Lawyers Section, a new section of the State Bar of Michigan, was launched at the State Bar Annual Meeting on October 1, 2010, in Grand Rapids. Planning and design of the new section was aided by leaders of the Bar's Senior Lawyers Section, which was dissolved on October 1. The new officers and council members elected on Oct. 1 became the leaders of the new section. The October 1 annual meeting featured a "Guide to Pro Bono" panel discussion chaired by newly-sworn State Bar of Michigan President Tony Jenkins. The panelists included American Bar Association Past-President Robert Grey, Michael C. Chielens (Executive Director of Legal Aid of Western Michigan), David L. Shaltz (of counsel to Chalgian & Trip Law Offices and experienced pro bono lawyer), and Richard F. Fellrath (Master Lawyers Section council member and experienced pro bono lawyer).

The Bylaws enacted by the Section establish five standing committees – Nominating, Service to Master Lawyers, Protection of the Public, Community Contribution, and Membership. The Nominating Committee recommends nominees to the Section for the offices of Chairperson-Elect, Secretary, Treasurer, and councilpersons on an annual basis. The Service to Master Lawyers Committee is responsible for developing and producing programs of interest to members of the Section, including educational programs, public service programs, career change programs, and talent utilization programs. The Protection of the Public Committee is responsible for developing, producing, and promoting materials and programs to assist attorneys in planning for and adjusting to changes in their professional status. The Community Contribution Committee is charged with identifying and following through on appropriate opportunities for members of the Section to contribute to their communities, partnering with other Sections and Committees where a mutual interest exists. The Chair established two subcommittees to the Service to Master Lawyers Committee – the Communications Subcommittee, chaired by Alfred Gade, and the Mentors Subcommittee, chaired by Asher Tilchin.

The following persons have served as chair of the various committees during the 2010-2011 year: Nominating Committee – Miles Gerberding; Service to Master Lawyers Committee – Ronald Keefe; Protection of the Public Committee – Greg Ulrich; Community Contribution – Mary Ellen Byrne; and Membership Committee – Jon Kingsepp.

Much of the Council's efforts during the inaugural year of the Section have been toward developing the best vehicles to communicate with section members and planning activities of interest and benefit to section members. As of May 1, the Service to Masters Committee is working on programming for a multi-day seminar to be held August 26-28 at Crystal Mountain Resort, as well as for the annual meeting, which will take place on September 15 in connection with the State Bar of Michigan annual meeting in Dearborn. The Protection of the Public Committee has begun an examination of an inventory attorney rule, the intent of which is to underscore the importance of planning for the orderly winding down of a solo or small firm practitioner's practice in the event of a sudden death or disability. The Council has also discussed the development of a mentoring model to match Master Lawyer Section members with young lawyers within areas of practice. The Section sent Miles Gerberding as its representative to the ABA Midyear Meeting of the Senior Lawyers Division of the American Bar Association in February in Atlanta, Georgia, who reported on

behalf of the Section, and will have a representative attending the State Bar's Bar Leadership Institute to be held in June at the Grand Hotel on Mackinac Island.

Resources Provided by the State Bar of Michigan in Support of Section Work:

The Section has been assisted in its work by staff liaisons Amy Castner, Dawn Evans, and Candace Crowley. The Section is provided financial information relative to its revenue and expenditures by the Finance Division and receives staff assistance with electronic publications and communications from the Communications Division.

Future Goals and Activities:

The Section continues to work on ways to involve and serve its membership, consistent with its Bylaws, by developing programming and disseminating information to its members in areas of interest. The Section anticipates both regular and periodic use of electronic and print forms of communication to make members aware of developments that impact them, such as changes in the Michigan Rules of Professional Conduct, as well as to solicit from members input about what type of programming would be helpful or well-received. In the coming year, the Section anticipates increasing membership in its various committees; development of a model mentor program that can be replicated in various parts of the state, linking Section members with young lawyers seeking guidance; completion of a proposed inventory rule for consideration by the State Bar; and increased participation by members in the Section's annual meeting and other events.
