

**TAXATION SECTION  
MINUTES OF ANNUAL MEETING**

Council Chairperson, Edward M. Deron, called the annual meeting of the State Bar of Michigan Taxation Section to order on September 12, 2003 at 9:30 a.m.. The meeting was held at the Lansing Center, Room 103, Lansing, Michigan.

A. MINUTES.

The minutes of the last annual meeting of the Taxation Section held on September 26, 2002 were distributed by Council Secretary at that time, Eric M. Nemeth. There being no comments, on motion duly made and seconded, the minutes were accepted.

B. TREASURER'S REPORT.

Council Treasurer, Eric M. Nemeth, presented the treasurer's report for the period October 1, 2002 through July 31, 2003.

C. AMENDMENT TO BYLAWS.

Ed Deron reported that an amendment to the bylaws of the Tax Section had been duly submitted and published in the August edition of the *Michigan Bar Journal*. The purpose of the amendment is to allow the Tax Section to move its annual meeting from being held in conjunction with the annual meeting of the State Bar of Michigan to such time and place as may be arranged by the Council. Specifically, Ed reported that the amendment would delete Section 1 of Article VII of the bylaws and replace it as follows:

Section 1. The annual meeting of the Section shall be held during the Annual Meeting of the State Bar of Michigan, in the same city or place as such Annual Meeting of the State Bar of Michigan, or at such other time and place as may be arranged by the Council (Emphasis Added), with such program and order of business as may be arranged by the Council.

Upon motion duly made and seconded, the amended bylaws were unanimously accepted and seconded.

D. NOMINATION AND ELECTION OF OFFICERS.
