Council Chairperson, Jess A. Bahs, called the meeting to order at approximately 3:00 PM.

MINUTES

The Minutes of the last meeting of the Council had been previously distributed. There being no changes to the Minutes, the motion by Gina M. Torielli, seconded by David B. Walters, to accept the revised Minutes was unanimously carried.

TREASURER'S REPORT

Gina M. Torielli submitted a report for the period from October 1, 2008 to May 31, 2009. The report indicated cash of approximately \$110,000 on hand at May 31, 2009. Gina reviewed her report with a comment that the amounts of actual revenues including dues are apparently fully reported for the full year. In addition to reporting revenue below budgeted amounts, Gina added that additional expenses were expected before year end so as raise total expected expenses for the year to approximately \$85,000 which is well below the budgeted amount but exceeds revenues for the year by as much as \$20,000. The actual cash balance at year end is projected to be reduced to around \$100,000 due to annual expenses exceeding annual revenue by approximately \$20,000. A motion to approve the Treasurer's report was made by Ronald T. Charlebois, seconded by John M. O'Hara, and unanimously approved.

1. Continuing Professional Education - After Hours Tax Law Series – Paul McCord. Mary Hiniker from ICLE submitted a report on the current registrations for the 2009-2010 After Hours Tax Law Series. Her report indicated that the first session regarding impact of the economic stimulus and other 2009 legislation scheduled for October 6th will be well attended and the preliminary numbers suggests that the later sessions should also have satisfactory attendance.
2. E-Newsletter – John O'Hara John requested information from Council members as to Section and/or Committee activities he could cite in the next newsletter.
3. 2010 Tax Conference – John O'Hara John reported that considerable activity has occurred in preparation for the May 20th Tax Conference. In addition to securing the facilities at the Rock Financial Showplace in Novi, two sponsors of the 2009 event have agreed to continue to support the 2010 Tax Conference. John also reported on the preliminary budget for the Conference. Both John and Jeff Kirkey from ICLE detailed the \$5,000 ICLE marketing budget that they had agreed upon.
