Kamau Sandiford serves as the Clean Slate Program Manager at Safe & Just Michigan (SJM), an organization dedicated to advancing criminal justice reforms aimed at ending mass incarceration and fostering safer communities.

At Safe & Just he oversees expungement outreach initiatives across the state, assisting individuals in removing old criminal records that hinder access to better housing and employment opportunities. He personally oversees every expungement fair in the state. The coordination of each of these events takes weeks/months. He will visit a site, work with state representatives, facility managers, local attorneys, law suits, the list goes on for days, to ensure that each fair is a success. He has personally had a hand in most expungements in the state over the last several years. He has trained hundreds of attorneys to assist and he never tires of being asked the same question over and over.

Before joining Safe & Just in 2021, he spent six years as an expungement attorney at Cooley Law School's Access to Justice Clinic in Grand Rapids. During this time, he witnessed Michigan's expungement laws evolve from being highly restrictive to becoming some of the most expansive in the nation, notably introducing the automatic expungement of certain felonies. He is currently the foremost expert in expungement law in the state. His commitment to public interest law is evident through his extensive work in expungement, where he has helped numerous individuals overcome the barriers posed by past convictions.

Kamau has also been instrumental in increasing public awareness of the new Clean Slate laws and assisting individuals in navigating the often complex expungement petition process. His dedication to criminal justice reform and his efforts to assist justice-impacted individuals in reintegrating into society align closely with the criteria for the State Bar of Michigan's Unsung Hero Award. This award honors attorneys who exhibit the highest standards of practice and commitment for the benefit of others.

His unwavering commitment to improving the lives of those affected by the criminal justice system makes him a compelling candidate for this recognition.
