# Online Michigan Criminal Law Resources

### Introduction

Michigan criminal law is constantly in a state of flux. During the pendency of a typical felony case, whether before trial or on appeal, literally hundreds of decisions will be released by the appellate courts of this state, some of which will likely have a direct bearing on the case.1 The legislative branch of state government is equally active. In the 2006-2007 session, for example, the governor signed over 600 public acts into law, many of which directly changed criminal law and procedure.2 Effectively finding the controlling Michigan authority may make the difference between prison and freedom for a client.<sup>3</sup> This article offers practical tips for finding Michigan criminal law resources quickly and cheaply online.

#### Case Law

The Michigan Court of Appeals maintains a website at http://courtofappeals.mijud.net/resources/opinions.htm that provides Michigan Supreme Court opinions and published and unpublished Michigan Court of Appeals opinions. The site is searchable by keyword, party, and date. Docket information and orders are also available.
