The section joined the State Bar in opposing any change in

the current process that gives the trial court discretion to award reasonable hourly fees within parameters defined in *Wood v DAIIE*, 413 Mich 573 (1982).

Prisons and Corrections Section

The Prisons and Corrections Section met in November to begin the planning of a springtime summit on mental health issues and the criminal justice system. The council also adopted a public policy position recognizing the right of the Parole Board to grant medical paroles pursuant to MCL 791.235(10). The council has two vacancies; interested parties may notify the section chair. Representative Mark Meadows and Terry Jungle, director of the Michigan Sheriffs Association, addressed the council in December.
