
Introduction and Dedication FAMILY LAW



This is the first *Michigan Bar Journal* family law theme issue that is being dedicated to honor a colleague. The Family Law Section Council of the State Bar of Michigan voted unanimously to dedicate this theme issue to Norman N. Robbins.

Norm is the consummate professional. He has been an inspiration to all who have had the good fortune of working with him, either as his adversary in a case or by being involved with him in one of his many endeavors. This issue includes articles about cutting-edge topics, written by skilled family law practitioners James P. Cunningham, Karen S. Sendelbach, Mark A. Snover, and Daniel R. Victor. When Norm began practicing family law, the content of these articles was not even on the radar screen. Mr. Cunningham's article addresses a common issue in family law cases—whether property is marital or separate. After discussing the current state of the law, Mr. Cunningham argues the need for legislative action pertaining to this issue.
